Environmental & Intergovernmental Reviews

In cooperation with State Agencies, PlanRVA routinely is requested to provide environmental and intergovernmental reviews. PlanRVA staff circulate the review requests among member locality staff for comments and questions prior to submitting a response to the requesting State Agency.

Environmental reviews can include:

- **Environmental Assessments and Impact Reports** Virginia code requires state agencies to prepare an environmental impact report (EIR) for each major state project.
- Coastal Consistency Determinations and Certifications Due to receipt of Federal funds or permits, proposed projects must prove consistency with the enforceable policies of Virginia's Coastal Zone Management Program.
- Groundwater Withdrawal Permits PlanRVA staff receives notice of Groundwater Withdrawal Permits in the Eastern Virginia Ground Water Management Area (GWMA). The eastern portion of PlanRVA is located in the Eastern Virginia GWMA. All jurisdictions in the Eastern Virginia GWMA are notified of pending permits as part of this process, therefore PlanRVA receives review requests for projects outside of the Richmond region. - **Virginia Water Protection (VWP) Permits** DEQ issues VWP Permits for activities related to the quality of surface waters in the Commonwealth including the filling, dredging, draining or excavation of wetlands, streams, or other state waters. Surface water withdrawals are also permitted through VWP permits.
- Virginia Pollutant Discharge Elimination System (VPDES) Permits DEQ issues VPDES permits to any person who discharges any pollutant into surface waters of the Commonwealth from a point source.

Intergovernmental reviews can include:

- State Agency grant applications for Federal funding, including:
 - CERCLA grant funds from US EPA (Superfund programming and site remediation)
 - Virginia Coastal Zone Management Program funding from the National Oceanic and Atmospheric Administration
 - o Diesel Emission Reduction Act (DERA) State Clean Diesel funds from US EPA
 - Capitalization funds for the Virginia Clean Water Revolving Loan Fund for wastewater treatment facility improvements from US EPA
- FHWA Section 5310 funding for projects involving transit and mobility enhancements for seniors and individuals with disabilities.

Located within the Richmond Region

Land Lease for Non-Aeronautical Use/ Commercial Development at Richmond Executive-Chesterfield County Airport

Chesterfield

The County proposes to release approximately 20 acres of airport property from federal obligations so that a non-aeronautical use can be developed on the property. A long-term lease would then be established with a third party (likely the local Economic Development Authority, EDA) which would identify an appropriate commercial-use tenant for development. Approximately 17 of the 20± acres would be advertised for development; a separate area of approximately three acres would also be released from federal obligations and leased and/or maintained as green space, as may be needed for environmental mitigation in conjunction with future development. Wetlands field surveys were conducted on the airport property, including on the parcels proposed for release, in 2009, 2012, and 2013 as part of an Environmental Assessment (EA) effort. The 2009 survey delineated an area of wetlands between the two areas to be released. The United States Fish and Wildlife Service (USFWS) National Wetlands Inventory (NWI) also identifies wetlands on the 17± acre area proposed for commercial development. The release of the property from federal obligation, which is an administrative action, would not have impacts on wetlands; however, the future development on the parcel could impact wetland areas. The developer would be responsible for any required wetland delineations, permits, and mitigation measures and the associated local, state, and federal coordination. A portion of the property has been identified as Resource Protection Area (RPA); this res not intended for development. The future developer of the parcel would be responsible for ascertaining the boundaries of RPA areas and coordinating with the County and DEQ if RPA impacts are anticipated. PlanRVA staff did not receive any responses from member locality staff concerning this review. PlanRVA staff responded with no comments.

Located outside - but potentially impacting - the Richmond Region

CZM Projects of Special Merit

Hampton Roads

The proposed project will result in a regional strategy and planning framework for the HRPDC that could be used as a template by other coastal regions in Virginia. The strategy and framework will result in the development of recommendations for local, regional, and state strategies, including recommendations for a new coastal hazard enforceable policy. Specifically, the project will focus on assessing the current state of resilience planning in Hampton Roads localities, identifying opportunities for improving local resilience policies (e.g., zoning ordinances, floodplain management ordinances, public facilities manuals), and developing a process for coordinating multi-jurisdictional collaboration, planning and implementation of both policies and projects. PlanRVA staff received no comments from locality staff. PlanRVA staff responded with support for the grant application and proposed project.

CNU Groundwater

Newport News

Christopher Newport University has applied for a new permit for groundwater withdrawal in Newport News, Virginia. The permit would allow the applicant to withdraw an average of 22,466 gallons per day. The groundwater withdrawal will support athletic field irrigation. The proposed withdrawal will utilize the surficial and/or the Yorktown-Eastover aquifer at a depth between 48 and 92 feet below the land surface at the withdrawal site. DEQ has made a tentative decision to issue the permit. PlanRVA staff received no comments from member locality staff. PlanRVA staff resp nded with no comments about the proposed permit.
