1. Welcome and Introductions

b. Approval of September Meeting Minutes

3. Standing Committee and Other Reports

a. Executive Committee & Chairman's Report

1) CVTA MOU Update

Ms. Heeter reported on the details of the MOU.

On motion by James M. Holland, seconded by Cynthia I. Newbille, the members of the PlanRVA Commission voted to approve the CVTA Support MOU as amended and presented (roll call vote, see Appendix A).

2) Key Imperatives – FY2023

Ms. Heeter reviewed the key imperatives. Commissioners had comments and questions and Ms. Heeter offered clarification on efforts to secure various grant funds as well as efforts to increase participation with VACo.
