CALL TO ORDER

In the absence of the chairman, CTAC Vice Chairman Herbert A. Richwine called the March 21, 2019 CTAC meeting to order at approximately 12:00 p.m.

PLEDGE OF ALLEGIANCE

All present stood and recited the Pledge of Allegiance.

At the request of Chairman Richwine, all present observed a moment of silence in remembrance of Roy Lee Bryant, Jr., long-time CTAC member and staunch advocate for transportation disadvantaged persons in the Richmond region.

A. ADMINISTRATION

- 1. Approval of March 21, 2019 CTAC Meeting Agenda On motion of Upton S. Martin, seconded by Upton S. Martin, CTAC unanimously approved the November 15, 2018 meeting agenda as presented.
- 2. Open Public Comment Period Sid Del Cardayre expressed disappointment that Van Go Transportation was not appointed to move over from EDAC to CTAC and said they are still willing to help CTAC in any

> way they can. It is important that the region's public leaders get clear, relevant input from the private, for-profit industry he serves in – nonemergency medical transport, shuttle and school transportation services. He said the private, for-profit industry understands the logistics and costs; when there is a need for that kind of input, he is available to serve on ad hoc committees or subcommittees and to assist in transportation planning efforts. Chairman Richwine thanked Mr. Del Cardayre for his comments.

> Two guests were introduced. Chairman Richwine introduced Phil Plymale, a neighbor from Chesterfield County, and Upton Martin introduced J. D. Longest from Ashland.

3. Approval of November 15, 2018 CTAC Meeting Minutes – On motion of Walter L. Johnson, seconded by James R. Barrett, CTAC unanimously approved the January 17 CTAC meeting minutes as presented.

B. PRIMARY MEETING TOPICS

1. CTAC Membership and Function Discussion – Chet Parsons, RRTPO Secretary, asked Ken Lantz to review the EDAC and CTAC Membership Report which he compiled. Mr. Lantz reported the origins of both committees noting that the Citizens Transportation Advisory Committee (CTAC) was initiated in 1980 and the Elderly and Disabled Advisory Committee (EDAC) was initiated in 1983 as an ad hoc committee of CTAC. Mr. Lantz reviewed membership variances and important milestones in the history of these committees. He reported that in the records of these committees, many of the same issues voiced in 1999 are still being voiced today regarding communication, the role of CTAC, membership composition, direction and mission. There was a list of strengths and weaknesses as presented at the September 28, 1999 CTAC meeting.

Mr. Parsons distributed and reviewed a four-page handout detailing separately the current local government and the at-large membership composition on CTAC. There were also suggestions for potential additions to fill the five unfilled at-large membership slots available on CTAC and for the CTAC Equity Work Group.

There was extensive CTAC discussion regarding membership and the role and function of CTAC and discussion was continued to the May 16 meeting.

2. Complete Streets Update – Phil Riggan, RRTPO planner, provided an update on the Complete Streets initiative that CTAC recommended to the RRTPO for consideration in September. Development of a Complete Streets regional multimodal policy was referred to the RRTPO Technical Advisory Committee (TAC) and after consideration at several meetings, TAC reported a recommendation back to the RRTPO. The RRTPO policy board affirmed the FY19 Unified Planning Work Program task <u>2.61 Bicycle and Pedestrian Connectivity</u> to use the Complete Streets work efforts with a pilot community, the Town of Ashland, to guide the preparation of a regional Complete Streets toolbox for use and reference by the jurisdictions in the Richmond region.

Mr. Riggan reviewed the definition of Complete Streets, examples of Complete Streets principles already incorporated in the region and CTAC Minutes March 21, 2019 Page 3

> discussed the Complete Streets study in Ashland being conducted by Smart Growth America, the Complete Streets Coalition, the Department of Rail and Public Transportation and the RRPDC.

There were several questions and comments from CTAC members regarding the objective of the Ashland Complete Streets pilot study and how resultant policy would impact other jurisdictions in the region.

C. OTHER BUSINESS

- 1. CTAC Chairman's Report Chairman Richwine had nothing to report.
- **2. RRTPO Updates** Chet parsons, RRTPO Secretary, reported on the following items:
 - a. RRTPO Meeting Report for February 7 and March 7 Reviewed highlights from the staff report included on pages six and seven in the agenda package.
 - b. TAC Meetings Report for February 21 and March 12 Reviewed highlights from the staff report included on page eight and nine of the agenda package.
 - c. FY20 FTA Section 5310 Applications Approved by the RRTPO Ken Lantz, RRTPO planner, noted materials included in the agenda package and reviewed the amount of funding and applications for Federal Transit Administration (FTA) Section 5310 funds. The RRTPO policy board recently endorsed those applications and, if funded, will add them to the Transportation Improvement Program for inclusion in the statewide Six-Year Improvement Program.
 - **d.** Meeting Opportunities There are two meeting opportunities included on page 17 of the agenda package. The Ashland to Petersburg Trail Feasibility Study open house meeting on March 26 and the RRTPO Active Transportation Work Group meeting with a panel of three experts on the future of automated vehicles and how they may interact with non-motorized vehicles and pedestrians. Details are included in the agenda package.
 - e. Other Chet Parsons noted the tendency to refer to the RRTPO policy board as just the RRTPO. He said he is trying to change that because the RRTPO is the sum of all of the committees, staff and organization including the RRTPO policy board. He is trying to change that reference with staff and he invited CTAC to consider that as well.
- 3. CTAC Announcements and Open Comment There were no comments.
- **4. Future Meeting Topics** Chet Parsons noted Future Meeting Topics and said he hopes to have a guest speaker to discuss public engagement and best practices to utilize the skills of this group to better engage the public.
- 5. Next CTAC Meeting: May 16, 2019 Chairman Richwine noted the next meeting date.
- 6. Other Business No other business was brought forward.

Subj: RRTPO Policy Board and TAC Meetings Report

The following presents a brief report on major business and action items from the April 4 and May 2, 2019 Richmond Regional Transportation Planning Organization (RRTPO) policy board and the RRTPO Technical Advisory Committee (TAC) April 9 and April 23 meetings.

Election of FY 20 Officers

The RRTPO policy board elected John H. Hodges, Town of Ashland, as the FY20 Chairman and Floyd H. Miles, Sr., Charles City County, as the FY20 Vice Chairman, both to serve a term of office from July 1, 2019 through June 30, 2020.

FY20 – FY25 RSTP and CMAQ

The RRTPO policy board approved allocations of Regional Surface Transportation Program (RSTP) and Congestion Mitigation and Air Quality (CMAQ) program funds for projects recommended and approved at the March and April TAC meetings and the April and May RRTPO policy board meetings. These projects and allocated funds are designated for inclusion in the Transportation Improvement Program and submission to the Commonwealth Transportation Board (CTB) for the statewide Six-Year Improvement Program (SYIP)

Transfers of funds, as recommended by TAC, were approved by the RRTPO policy board to accommodate funding projects in the correct year over the life of the six-year RSTP and CMAQ program funding.

SMART SCALE Round 3: Comments to the CTB

At the April 9 meeting, and again at a special called meeting on April 23, TAC considered draft comments on Round 3 of the Smart Scale process. These comments were integrated into a letter to the CTB to make them aware of funding impacts from the Smart Scale program on the Richmond region

I-81 Corridor Fund

At the April 4 RRTPO policy board meeting, a decision was made for the chairman to address the Commonwealth Transportation Board (CTB) at the Spring Six-Year Improvement Program (SYIP) Public Meeting being held in Richmond on Thursday, April 25, regarding the I-81 Corridor Fund and associated amendments made by the Governor that impact interstates in the Richmond region. Recent action to fund the I-81 corridor, which included additional annual funding for I-64, I-95 and other interstate highways in Virginia were important components of this conversation. TAC agreement was reached that the message to the CTB should be that the Richmond region has significant needs already identified through applications, plans and studies; the region is unified and will be with the CTB at the table; the region is willing to work with the CTB to provide projects that are ready to move forward.

FY19 Unified Planning Work Program Amendments

Amendments to the FY19 UPWP budget were approved by TAC and the RRTPO policy board in March and again in May to reallocate the distribution of Federal Planning (PL) funds, Federal Transit Administration (FTA) Section 5303 Carryover funds and FTA Section 5303 current year funds among staff and consultant work tasks. There were no net changes to any work task budgets or the UPWP budget as a whole.

Draft FY20 Unified Planning Work Program (UPWP)

The RRTPO policy board approved the FY20 UPWP, as recommended by the TAC, for public review and comment. The document was subsequently distributed for public review at one library in each jurisdiction and at the RideFinders office. Additionally, the FY20 UPWP is posted for public review and comment on the PlanRVA website and is available in the PlanRVA office. The public review period ends June 14, 2019 and all comments and staff responses received on the Draft FY20 UPWP will be provided to the RRTPO policy board for consideration. The RRTPO policy board is expected to take adoption action at the June 28 meeting; the FY20 UPWP will then be submitted to the Federal Highway Administration, the Federal Transit Administration, VDOT and the Department of Rail and Public Transportation for approval for funding.

Current Work Efforts Update

RRTPO Active Transportation Work Group Meeting Presentations on the Future of Automated Vehicles May 14, 11:00 a.m. – 12:30 p.m. RRPDC Board Room

The Richmond Regional Transportation Planning Organization (RRTPO) Active Transportation Work Group is meeting immediately after the TAC meeting today to hear presentations from three experts on the future of automated vehicles and how they may interact with non-motorized vehicles, bicycles and pedestrians. Presenters are from VDOT, the University of Virginia, and Kapsch TrafficCom USA; time will be provided for questions and answers. The meeting is open to the public.

Complete Streets Project Update and Workshop Tuesday, June 25 (1:00-4:00 PM) and Wednesday (9:00-4:00 PM) Ashland Town Hall in Council Chambers

The Complete Streets project is a comprehensive region-wide analysis of specific design practices and principles that make a street function effectively for all users and modes of travel. Smart Growth America and Michael Baker International are serving as the consultants on the project. Due to its urban, suburban and rural character, the Town of Ashland is a representative pilot project for consideration of complete streets principles in the region. Building on input from the first workshop in April, the second 1-1/2-day workshop will focus on design guidelines and policy development specifically for the Town of Ashland with applicability to the region. This workshop is open to all locality officials, staff and multimodal advocates. Please RSVP if you are interested in attending to Phil Riggan, priggan@PlanRVA.org or 323-2033.

Park and Ride Investment Strategy

The next steps of this regional data-driven analysis of priority areas/sites for future park & ride locations will be to finalize project recommendations with planning level cost estimates, timetables, funding sources and implementation strategies identified for the top 10 sites. Presentations of the study are planned for the TAC meeting on June 11, and the RRTPO policy board on June 27.

Ashland Trolley Line Trail

The purpose of this study is to identify the potential for a 14-mile multi-use trail using the abandoned trolley line corridor and other rights-of-way to link the Town of Ashland through Hanover and Henrico counties to the northern edge of the City of Richmond. The Ashland Trolley Line Trail advisory group will meet as a group in June (every other month), while the National Park Service through their Rivers, Trails and Conservation Assistance (RTCA) Virginia program will assist in guiding individual localities on site specific field trips to explore barriers and opportunities for linkage among segments.

FISCAL YEAR 2020 UNIFIED PLANNING WORK PROGRAM

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: Richmond Regional Transportation Planning Organization (RRTPO) Community Transportation Advisory Committee (CTAC) members are requested to review the enclosed *RRTPO Fiscal Year 2020 Unified Planning Work Program* (UPWP) as part of the RRTPO policy board authorized public review period.

BACKGROUND: The FY20 UPWP is the RRTPO budget and work program for the upcoming fiscal year, July 1, 2019 through June 30, 2020. Activities programmed in the UPWP address federal and state planning and programming requirements and address regional transportation planning issues and needs. Additionally, the UPWP addresses federal and state RRTPO planning and programming requirements which are required as a condition for the state and region to remain eligible for federal-aid highway and transit funds. The funding sources supporting the RRTPO program activities come from federal, state, and local funds.

The FY20 UPWP is organized with focus on four core program areas: Program Support and Administration, General Development and Comprehensive Planning, Long-Range Transportation Planning, Short-Range Transportation Planning, and Rural Transportation Planning. Program Support and Administration is the policy, management and operations platform that supports the remaining program areas. The program objectives, work elements, responsibilities, budgets, products and schedules are included within each core program area.

As in past UPWP documents, there are work tasks that are included primarily as "project monitoring"; while the RRTPO is a participating partner in the effort, the designated lead role is undertaken by another agency or organization such as GRTC, DRPT or VDOT. FTA requires projects and studies receiving FTA funding to be included in the UPWP; this is not a requirement shared by FHWA.

Funding Sources

The two primary funding sources supporting the work program are FHWA/PL funds and FTA Section 5303 funds. These funds are matched by state and local sources on an 80% federal (FHWA and FTA) 10% state (VDOT and DRPT), and 10% local (RRPDC member dues and RRTPO special assessment) basis. Additional funding has been available in prior years through FHWA/RSTP which funds an on-call consultant to support RRTPO Regional Travel Demand Model development and analysis. These funds are matched by state sources with 80% federal funding (FHWA) and 20% state funding (VDOT).

The RRTPO policy board approved the *Draft Fiscal Year 2020 Unified Planning Work Program* for public review at the May 2, 2019 and will consider comments, revisions and final approval at the June 27 RRTPO policy board meeting. The public review period will end June 14. Following RRTPO policy board adoption, the document will be submitted to FHWA, FTA, VDOT and DPRT for final approval for funding.

INTRODUCTION

The Unified Planning Work Program (UPWP)

The purpose of the UPWP is to promote a unified regional approach to transportation planning in order to achieve regional goals and objectives. Additionally, the UPWP serves to document proposed expenditures of federal, state and local transportation planning funds, and provides a management tool for RRTPO and the funding agencies in scheduling major transportation planning activities, milestones, and products.

The UPWP is required of all metropolitan planning organizations (MPOs) as a condition to receiving federal funds. The RRTPO is the federally designated MPO for the Richmond region and consists of the member governments as shown in Figure 1.

The goal of the UPWP is a well-functioning process and program that meets the federal and state transportation planning requirements. This effort involves the public, interested parties, and the RRTPO in developing a multimodal, continuing, comprehensive, and cooperative transportation planning and programming process. A requirement of Section 450.308(c) of the Metropolitan Planning regulations is that Transportation Management Area (TMA) designated MPOs shall include a discussion of the planning priorities facing the metropolitan planning area. Further discussion of these priorities is provided in the various work tasks.

The UPWP is the RRTPO budget and work program for the upcoming fiscal year which begins on July 1, 2019 and concludes on June 30, 2020. The UPWP addresses federal/state planning and programming requirements, addresses regional transportation planning issues and needs, and includes activities required for the state and region to remain eligible for federal-aid highway and transit funds. The funding sources supporting the RRTPO program activities come from federal, state and local funds.

PlanRVA and the RRTPO Planning Process

The FY20 UPWP continues to be organized with four core program areas: Program Management, Transportation Planning, Data and Analysis, and Financial Programs. Program Management is the policy, management and operations platform that supports the remaining three program areas. The program objectives, work elements, responsibilities, budgets, products and schedules are included within each core program area. In addition to grouping work tasks into four core areas, an effort has been made to identify how work tasks in each section correlate to the goals approved by the RRTPO in plan2040. The appendices consolidate information necessary to understanding and implementing the RRTPO program requirements.

As in past UPWP documents, there are work tasks that are included primarily as "project monitoring"; while the RRTPO is a participating partner in the effort, the designated lead role is undertaken by another agency or organization such as GRTC, DRPT or VDOT. FTA requires that projects and studies receiving FTA funding to be included in the UPWP; this is not a requirement shared by FHWA. All partners are provided the opportunity to incorporate project updates into the work task which those organizations or agencies lead.

The two primary funding sources supporting the work program are FHWA/PL funds and FTA Section 5303 funds. These funds are matched by state and local sources on an 80% federal (FHWA and FTA) 10% state (VDOT and DRPT), and 10% local (RRPDC) basis. Additional funding includes FHWA/RSTP which are matched by state sources with 80% federal funding (FHWA) and 20% state funding (VDOT). The FHWA/PL funding allocations for FY 20 from VDOT and the FTA 5303 funding allocations from DRPT have been received.

Work Program Priorities

The RRTPO-approved FY20 UPWP priorities focus on fully addressing the recommendations from the August 2017 federal certification report, completing existing work tasks that span from FY19 into FY20, and advancing new initiatives. These priorities are outlined below.

Federal Certification Review Comments, FAST Act and Other USDOT Priorities

- Address recommendations and corrective actions from the August 2017 certification report, including a simpler schedule and results oriented approach to the UPWP with clear indications of responsible parties for work tasks.
- Execution of revised agreements on statewide planning and MPO Coordination between the RRTPO, the Tri-Cities MPO and partners
- Incorporate as appropriate, USDOT Every Day Counts analytical tools, public engagement strategies, planning and design considerations, and operational improvements into work program tasks and elements.

Continuation of Existing Work Efforts

- Continue to develop the Regional Travel Demand Model to support transportation planning, research and analysis, including small area, sub-area, corridor and scenario planning tasks
- Continue the regional conversation on transit and how to best meet the needs of the region
- Continue the regional conversation on developing bicycle and pedestrian facilities with local, regional, state and national partners.

FY20 Focal Areas


- Development of a new Long-Range Transportation Plan with emphasis on scenario planning, performance measures, and increased opportunity for public engagement.
- Expanding access to transit. Focus work tasks to inform the completion of a regional park and ride plan, identify bicycle and pedestrian connections to transit stops, and development of a Phase 2 of the Transit Vision Plan that focuses on *Critical First Steps* for high frequency service as identified in the Transit Vision Plan. The work will come from the recommendations in the Greater RVA Transit Vision Plan and the GRTC Transit Development Plan.
- Provide a forum to discuss active transportation and its impacts to the region, including multi-purpose regional trail development and connections between home, work, and recreation.

The UPWP fulfills the federal requirement under 23 CFR §450.308:

(b) An MPO shall document metropolitan transportation planning activities performed with funds provided under title 23 U.S.C. and title 49 U.S.C. Chapter 53 in a unified planning work program (UPWP)...

(c) . . . each MPO, in cooperation with the State(s) and public transportation operator(s), shall develop a UPWP that includes a discussion of the planning priorities facing the MPA. The UPWP shall identify work proposed for the next 1- or 2-year period by major activity and task (including activities that address the planning factors in §450.306(b)), insufficient detail to indicate who (e.g., MPO, State, public transportation operator, local government, or consultant) will perform the work, the schedule for completing the work, the resulting products, the proposed funding by activity/task, and a summary of the total amounts and sources of Federal and matching funds.

Metropolitan Planning Factors and RRTPO FY 2020 Priorities

The 2015 *Fixing America's Surface Transportation Act (FAST ACT)* continues the principles of integrated planning first set forth in 1992 with the Intermodal Surface Transportation Efficiency Act

Under the *FAST Act*, MPOs must consider ten (10) planning factors when developing transportation plans and programs.

- 1. Support the economic vitality of the metropolitan area, especially by enabling global competitiveness, productivity, and efficiency;
- 2. Increase the safety of the transportation system for motorized and non-motorized users;
- 3. Increase the security of the transportation system for motorized and non-motorized users;
- 4. Increase the accessibility and mobility of people and freight;
- 5. Protect and enhance the environment, promote energy conservation, improve the quality of life, and promote consistency between transportation improvements and state and local planned growth and economic development patterns;
- 6. Enhance the integration and connectivity of the transportation system, across and between modes, for people and freight;
- 7. Promote efficient system management and operation;

- 8. Emphasize the preservation of the existing transportation system
- 9. Improve the resiliency and reliability of the transportation system and reduce or mitigate stormwater impacts of surface transportation; and
- 10. Enhance travel and tourism.

Development of this FY 2020 UPWP has been guided by regulations requiring the RRTPO planning process to consider and implement projects, strategies, and services that address these ten metropolitan planning factors. Each of these planning factors affects nearly every task. The degree of consideration and analysis is based on the scale and complexity of many issues, including transportation system development, land use, employment, economic development, human and natural environment, and housing and community development (*23 CFR 450.306(b)*). The matrix on page nine summarizes the applicability of each metropolitan planning factor to the 2020 work program tasks.

FAST Act Implementation

RRTPO implementation efforts in 2019-2020 will focus on (1) improving public engagement; (2) developing performance measures; and (3) a myriad of activities that will inform the 2020 update of the long-range transportation plan, plan2045.

Regional Models of Cooperation

Regional Models of Cooperation provide a framework and process for States and MPOs to develop multijurisdictional transportation plans and agreements to improve communication, collaboration, policy implementation, use of technology and performance management across agency boundaries. Multijurisdictional planning combines many perspectives to improve coordination and implement effective planning across wide geographic areas. Regional models of cooperation offer a competitive advantage by improving decision-making and saving time and money through shared resources. Examples include freight and congestion management coordination.

Ladders of Opportunity

Work – Infrastructure investment creates jobs and paves the way for business, particularly small and disadvantaged business enterprises

Connect – A multimodal transportation system provides Americans with safe, reliable, and affordable connections to employment, education, healthcare, and other essential services

Revitalize – Transportation infrastructure can lift up neighborhoods and regions by attracting new opportunities, jobs, and housing

Engagement with CTAC provides an opportunity for citizen and interested party input to inform and advise the RRTPO on plans, studies, issues, and other matters related to planning transportation systems and services.

In addition to supporting CTAC and the work groups, the RRTPO encourages community engagement for each of its work products, including the Long-Range Transportation Plan and the Transit Vision Plan Phase II. There are various ways to get involved, including the PlanRVA website, open meetings, community events, and other methods specific to each program.

In order for Richmond to compete in the efficient movements of goods and services in the coming years, the region will need to identify, develop and implement intermodal strategies which will provide good connectivity for passenger movement, transfer of rail shipments, improved rail access for local truck shipments, expanded opportunity for air cargo movement, and alternative options of importing and exporting regional cargoes, such as by barge to the Port of Virginia's Richmond Marine Terminal. By ensuring the continued performance of the regional transportation system, the prevention of environmental degradation, while encouraging and attracting economic opportunities, the RRTPO will be promoting a high quality of life for our region.

The regional planning process can support policies that advocate investments in the rail system such as extension of sidings, crossovers, signal upgrades or grade-separation of crossings which can improve the performance of the rail system to the benefit of both passenger and freight movements.

FISCAL YEAR 2020 RRTPO STAFFING AND BUDGET

RRTPO Staff Resources

Eight personnel from PlanRVA are committed to full-time direct support of the tasks outlined in the FY 2020 RRTPO UPWP; another five personnel are committed in part-time direct support. Additional personnel may be assigned to consultant-led work tasks.

Primary responsibility for the UPWP rests with PlanRVA staff. There are particular cases where other partner agencies are assigned primary responsibility for specific activities, as delineated in the task descriptions; PlanRVA will provide support for these activities.

The PlanRVA Director of Transportation is responsible for overall program support and administration of the RRTPO work program tasks, as well as for interagency coordination with the other partner agencies. Although PlanRVA staff often form working groups and share in the performance of work program activities, each staff person dedicated to direct support of the work program is charged with primary responsibility for accomplishing specific tasks or subtasks.

Table 3 summarizes overall federal and local revenues budgeted by PlanRVA in FY 2020 to support the work of RRTPO. Federal funds budgeted constitute 80 percent of the total; state and local matching funds constitute 20 percent unless otherwise noted.




FIGURE 2. FY 2019 TOTAL RRTPO BUDGET BY TASK
