#### CALL TO ORDER

The Central Virginia Transportation Authority (CVTA) Nominating Committee Chair, Ms. Patricia Paige, presided and called the June 29, 2021 Special CVTA Nominating Committee (TAC) meeting to order at 10:50 a.m.

#### **CERTIFICATION OF MEETING QUORUM**

All members of the CVTA Nominating Committee were present and a quorum was certified.

# **CVTA Nominating Committee Chair's Report**

On Wednesday, June 30th, CVTA Nominating Committee Chair Patricia Paige called a special meeting of the committee, to be held at 11:00 a.m. on Thursday, July 1, 2021 at the offices of PlanRVA. All members of the Nominating Committee were notified of the special meeting. The meeting notice and agenda were immediately posted on the PlanRVA/CVTA website.

Chair Paige explained that she was uneasy with the decision of the committee at its June 29<sup>th</sup> meeting to nominate her for a seat on the CVTA's Finance Committee (FC), which would result in her replacing Mr. Carlos Brown on the FC. She said she would rather see continuity on the FC for the coming year, which had also been expressed by other members of the Nominating Committee on June 29. With that, Chair Paige invited a motion.

Canova Peterson, who had previously voted in favor of Paige's nomination on June 29 (the prevailing side), moved that the committee reconsider its prior motion/action to nominate Patricia Paige for an at-large seat on the FC. David Williams seconded the motion. Chair Paige invited all those in favor of the motion to vote "aye", all members of the Nominating Committee voted "aye", and the motion was approved.

With the nomination of Patricia Paige for an at-large seat on the FC now open for reconsideration, Canova Peterson moved that the Nominating Committee rescind Paige's nomination. David Williams seconded the motion. Chair Paige invited all those in favor of the motion to vote "aye", all members of the Nominating Committee voted "aye", and the motion was approved.

On motion of Patricia A. Paige, seconded by John H. Hodges, the CVTA Nominating Committee unanimously recommends the nomination of Carlos M. Brown, representing the Commonwealth Transportation Board, as a returning member for an at-large seat on the CVTA Finance Committee. Chair Paige invited all those in favor of the motion to vote "aye", all members of the CVTA Nominating Committee voted "aye", and the motion was approved.

This recommendation will be included as part of the election item in the July Authority meeting agenda.

## Adjournment

There being no further business, Chair Paige adjourned the meeting at 11:00 a.m. on July 1, 2021.
