SUBJECT FY24 – FY27 Transportation Improvement Program – Illustrative Projects List

BRIEF:

Staff have prepared TIP blocks for the proposed illustrative projects list in the FY24 – FY27 Transportation Improvement Program (TIP). This list is intended to serve as a standing endorsement for major projects from the ConnectRVA 2045 constrained long-range plan (CLRP) or vision list seeking federal discretionary funds and earmarks in the near term. The project list was drawn from projects that the RRTPO has previously endorsed for a discretionary grant application. This list of projects is not funded and the amendment to include this the illustrative projects will have no impact on fiscal constraint or the regional conformity analysis.

RECOMMENDED ACTION:

The Technical Advisory Committee should recommend approval of the requested amendment to the FY24 – FY27 Transportation Improvement Program to create an illustrative project section.

DISCUSSION:

Under Federal law and agreements with state agencies, the Richmond Regional Transportation Planning Organization (RRTPO) has authority to select projects and program regional Carbon Reduction Program (CRP), Congestion Mitigation and Air Quality (CMAQ), and Surface Transportation Block Grant (STBG) funds, including the Transportation Alternatives (TA) set-aside. Projects selected by the RRTPO to receive funding are included in the Six-Year Improvement Program (SYIP) for adoption by the Commonwealth Transportation Board (CTB).

For other funding programs, the RRTPO does not have authority to select projects but is responsible for adding projects to the Transportation Improvement Program (TIP). Based on federal regulations and RRTPO policy, all projects proposed to be added to the TIP are screened for consistency with the regional long-range transportation plan, ConnectRVA 2045, and the regional conformity assessment. All proposed revisions are also evaluated for fiscal constraint, or the ability to fund the project with projected revenues.

The proposed illustrative project list is an unconstrained list of priority projects that the RRTPO would pursue in the near term if additional funding were available. The draft TIP blocks can be found in Attachment A.




Figure 1: ConnectRVA 2045 Consistency Workflow

<u>ConnectRVA 2045 Consistency</u>: ConnectRVA 2045 establishes categories of projects which are regional in nature and must be included in the constrained long-range plan (CLRP) prior to inclusion in the TIP. Conversely, other project types are considered either local or programmatic in nature and can advance without being





specifically listed. The project types under each category can be reviewed in Chapter 5 of ConnectRVA 2045. Figure 1 graphically shows the consistency review process.

The projects proposed for the illustrative project section are all regional in character. Some projects are included in the ConnectRVA 2045 vision list, rather than the CLRP. As the funding being sought is not included in the ConnectRVA 2045 financial plan, pursuing this funding is still consistent with the ConnectRVA 2045 CLRP. An LRTP amendment may also be required depending on the funding breakdown for the projects prior to inclusion in the constrained TIP.

<u>Air Quality Conformity</u>: Portions of the RRTPO were formerly part of the 1997 8-hour Ozone Maintenance Area and projects in these areas must either be part of the Regional Conformity Assessment or must be exempt from air quality conformity analysis under federal regulations prior to being added to the TIP. Illustrative projects are not fiscally constrained and do not impact air quality conformity. The regional conformity assessment will need to be reviewed if the projects receive funding and are added to the constrained TIP in the future.

<u>Fiscal Constraint</u>: Constraint is the process of demonstrating that a proposed set of investments are possible with the expected revenues during the period of the plan. This demonstration requires the RRTPO to develop a financial plan which reflects expected revenues, investments to maintain the existing transportation system, and proposed improvements to the system. As this list of projects is unconstrained, there is no impact to the fiscal constraint demonstration in the FY24 – FY27 TIP.

SUBJECT Rural Public Transportation Options

BRIEF:

The RRTPO has heard concerns from several localities about the need for expanded public transportation options in rural areas. At the September Policy Board meeting, DRPT presented on funding opportunities which can create a pipeline to new public transportation (Technical Assistance for Planning > Demonstration Project > Transit Ridership Incentive Program (TRIP) service > Permanent Service with transit operator). The Workforce Development Grant Program was also reviewed as a funding stream to train staff to support public transportation. The Policy Board has directed the TAC to work with DRPT to develop a recommendation on the best use of the programs covered in the presentation to provide sustainable and fiscally constrained public transportation service in the entire Richmond region.

RECOMMENDED ACTION:

The Technical Advisory Committee (TAC) should appoint members to a reconvened Public Transportation Work Group to study the question and provide a recommendation to the full TAC.

DISCUSSION:

When it was created in 2020, a part of the Central Virginia Transportation Authority's codified mission was to direct 15% of all revenues collected to GRTC Transit System to address regional public transportation. GRTC has been working to identify ways to support rural localities that do not have fixed-route service. In 2021-2022, GRTC worked with the region's localities and agency partners to identify locations in the region where on-demand micro-transit would be feasible and beneficial, and to identify where, when, and how it should operate. The study involved active public engagement with a public survey, interviews and meetings with jurisdictions, providers, and other stakeholders. The study relied on a broad review of demographic, market and travel patterns and provided an overview of the literature offering best practice reviews and peer agency interviews.

The microtransit study process and preliminary results were reviewed and input on proposed pilot zones were conducted by the TPO Public Transportation Work Group at their August and September 2022 meetings. The Policy Board was briefed in detail on the study process and recommendations for short term pilot area projects for the first year at the November 3, 2022, Policy Board meeting. The CVTA has also been briefed on the microtransit study at its Dec 8, 2022, meeting. A link to the study can be found under Attachment A below.

Subsequent updates for the microtransit study to the RRTPO Policy Board recommended the first 3 pilot areas: Washington Park, Sandston-Elko and North Chesterfield that would be GRTC-operated using COVID relief funds. Phase 2 of the





study is focused on refining the recommended pilot zones and developing an implementation plan for FY24.

Continued consultation with the rural localities indicates that there is a desire for further coordination to provide a more comprehensive approach to understanding public transportation needs in the outlying areas of the region beyond micro-transit services. The Policy Board reviewed this need and a presentation on new transportation service from DRPT at the September meeting. The presentation can be found at the link for Attachment B below.

SUBJECT FY25 – FY30 Flexible Regional Funding Schedule

BRIEF:

Under Federal law and agreements with state agencies, the Richmond Regional Transportation Planning Organization (RRTPO) has authority to select projects and program regional Carbon Reduction Program (CRP), Congestion Mitigation and Air Quality (CMAQ), and Surface Transportation Block Grant (STBG) funds, including the Transportation Alternatives (TA) set-aside. Staff have prepared a draft schedule with a call for projects starting October 2. The goal is to complete the process by March, allowing sponsors to factor RRTPO funds into Smart Scale pre-application decisions.

RECOMMENDED ACTION:

None

DISCUSSION:

Under Federal law and agreements with state agencies, the Richmond Regional Transportation Planning Organization (RRTPO) has authority to select projects and program regional Carbon Reduction Program (CRP), Congestion Mitigation and Air Quality (CMAQ), and Surface Transportation Block Grant (STBG) funds, including the Transportation Alternatives (TA) set-aside. Projects selected by the TPO to receive funding are included in the Six-Year Improvement Program (SYIP) for adoption by the Commonwealth Transportation Board (CTB).

MAJOR PROGRAM CHANGES: There are two major changes to the program this cycle. First, all applications for projects which will lead to construction must include an estimate using the Cost Estimate Workbook (CEWB). Any successful projects that do not include a CEWB will not be eligible for any additional funding from the TPO. Applicants should still submit additional supporting estimate materials such as right-of-way worksheets and major item estimates as needed to support validation and screening.

The second major change is the Carbon Reduction Program (CRP). Consistent with the previous approach, applicants will apply for projects, however, there will no longer be a need to select funding programs. Staff will consider each application for every available funding source based on federal eligibility requirements. When allocating funds for new projects, funds will be programmed based on priority with more restrictive funds used first where possible.

<u>PRE-SCREENING</u>: Staff are working with VDOT to update the pre-screening and cost validation process due to the challenges experienced over previous rounds, including exploring a new module in the Smart Portal. Cost estimates and





schedules will be reviewed by VDOT after submission to support estimate decisions for scoring and leveraging for Smart Scale.

<u>DRAFT SCHEDULE</u>: Staff have prepared a draft schedule for applications and project prioritization. This schedule was developed with a goal of having tentative decisions in place in time for the Smart Scale pre-applications.
