The Richmond Regional Transportation Planning Organization (RRTPO) Community Transportation Advisory Committee Chair, Sera Erickson, presided and called the March 21, 2024, RRTPO CTAC meeting to order at 12:03 p.m.

On motion by John Leonard, seconded by Gordon Dixon, the members of the Community Transportation Advisory Committee voted unanimously to recommend RRTPO Policy Board approval of the document as presented. (voice vote).

#### 3. Update on CTAC Member Engagement Opportunities

a. Identifying Planning Issues and Solutions-Osborne Turnpike Case Study Mr. Busching provided a recap of the transportation planning process. He noted that there was a lot of feedback on the Osborne Turnpike project. He detailed the options/alternatives that were developed and the level of public involvement that was generated.

#### b. Scenario Planning Survey and Charette

Ms. Gordon gave a general overview of the scenario selector and noted it has been posted on all PlanRVA social media channels. She asked members to share the scenario selector and the survey with their networks to help increase participation.

She explained that a charette is scheduled for April 16<sup>th</sup> with some of the consultants who helped develop the scenario planning survey. CTAC members are invited to attend.

Ms. Gordan explained that the activity is to determine what civic and neighborhood associations, community organizations and media outlets are in each member's community and how to engage them. Committee members were also asked to determine what the community hubs are in their locality.

#### Authority meeting - April 26, 2024

#### **CVTA Annual Administrative and Operating Budget Approval**

Following a public comment period, the Authority held a public hearing on the proposed FY24 Administrative and Operating Expense Budget, then voted to approve the proposed budget as presented. Highlights of the budget include:

- Funds to finalize and publish the Fall Line Trail Wayfinding Plan.
- A focus on technology, including funds for the following:
  - A new CVTA website.
  - o Innovative web tools to engage the public.
  - Development of video content that supports storytelling about the impact of CVTA and regional project highlights.
  - Specialty software licenses to assist in data visualization, audience polling, and presentations.
  - Development of enhanced tools for sharing the CVTA story with the public and external partners, data. visualization (such as live dashboards, charts, and graphs), survey tools and real-time polling/preference surveys.

#### **Approval of SPAs:**
