Action Requested:

Motion to approve fulfillment of two new staff positions to be assigned to the Transportation Program area. Positions may be filled as soon as March 1, 2024.

Rationale:

These positions are deemed necessary in order to address current workloads within the Transportation planning group. The vacancy in the Director of Richmond Regional TPO was created by the transition of the PlanRVA Director of Transportation to the CVTA Executive Director position and has not been filled as of this report.

Additionally, also pursuant to this transition, Planning Leadership was reorganized to advance the following organizational objectives

- Regional Strategic Planning: improve integration of all PlanRVA activity regarding the Regional Strategic Plan
- Opportunity for current PlanRVA staff
 - Senior leadership was advanced in order to formally recognize their leadership roles in their respective planning areas
 - Advancement of senior leadership is also providing future advancement of existing planning and operational staff

Financial Impact:

The addition of these two positions is not expected to impact total actual FY2024 Personnel Costs. The following table shows that the savings from the Director of Richmond Regional TPO position is expected to be sufficient to accomplish 2 goals

- Redistribution of wages for Planning Leadership as of the beginning of FY2024 (07/01/2023) among the reorganized Planning Leadership as of 01/01/2024
- Inclusion of the wages for the 2 new Planning positions, targeted to start 03/01/2023

Funding for the new positions for FY2025 is expected to be funded through existing carryovers from current VDOT PL and DRPT Sec 5303 funding as experienced during recent fiscal years. Additionally, these two funding sources are expected to increase notably during the next fiscal years (FY2025-FY2027).
