**Whereas**, the Virginia Department of Emergency Management and Federal Emergency Management Agency, Region III officials have reviewed the "2022 Richmond-Crater MultiRegion Hazard Mitigation Plan" and approved it; and

**Whereas**, the nine local governments of PlanRVA have reviewed the "2022 Richmond-Crater MultiRegion Hazard Mitigation Plan" and approved it.

**Now, therefore, be it resolved**, that the Richmond Regional Planning District Commission adopts the "2022 Richmond-Crater Multi-Region Hazard Mitigation Plan" as an official plan; and

**Be it further resolved**, staff will submit this adopted resolution to the Virginia Department of Emergency Management and Federal Emergency Management Agency, Region III officials.

## Proposed Amendment 10 to the Central Virginia Solid Waste Management Plan – Shoosmith Landfill

#### **Background:**

The Central Virginia Solid Waste Management Plan (CVSWMP or Plan) was prepared for the Central Virginia Waste Management Authority (CVWMA) and 13 local governments within the Authority's service area in accordance with the requirements and provisions of Regulations for Solid Waste Planning (9 VAC 20-130-10 et seq.). The CVSWMP provides an integrated solid waste management strategy for the region. The CVSWMP was originally approved by the Department of Environmental Quality (VA DEQ) August 20, 2004 for the period 2004-2024 and most recently updated and approved by DEQ, on October 29, 2021 for the period of 2019-2039. Virginia Solid Waste Regulations 9 VAC 20-130-175, Amendments to plans, paragraph A, requires a major amendment to the solid waste management plan for any addition or cessation of landfill disposal capacity. A major amendment to the CVSWMP includes a public hearing, approval by the CVWMA Board of Directors, approval by the Richmond Regional and Crater Planning District Commissions and ultimate approval by the VA DEQ.

The Shoosmith Sanitary Landfill located at 11800 Lewis Road, Chester, Virginia in Chesterfield County is a municipal solid waste landfill. The landfill is permitted under Solid Waste Facility Permit Number 587 issued by the VA DEQ.

An expansion of this existing Landfill into an adjacent quarry (cells 27 and 28) was originally approved by the DEQ, however, the Article VII/VIII application required by the host community of Chesterfield County was not approved by the Board of Supervisors in July 2018. The outcome of litigation prevents the landfill from expanding into the quarry. Approximately 33,699,000 cubic yards (approximately 17 million tons) of capacity currently in the Plan will be removed by this amendment, as approved by the CVWMA Board of Directors and if approved by the Richmond Regional and Crater Planning District Commissions. It should be noted that this amendment only removes the cells related to the quarry and does not include the closure of the Shoosmith Landfill as there is capacity remaining in cells 1-26 that could be available.

The CVWMA Board of Directors held a public hearing regarding this proposed Amendment 10 to the regional Plan to remove this landfill disposal capacity that is and will no longer be available to the region. Interested parties were encouraged to review the 2019-2039 Plan and to comment on the proposed amendment at the regular meeting of the CVWMA Board of Directors at 9:00am on Friday, May 17, 2024 in the Large Conference room on the first floor of 2104 W Laburnum Avenue, Richmond VA 23227. A virtual option for comments during the public hearing was also made available. No comments were received from the public before or during the hearing. CVWMA did receive a written response from SCS Engineers on behalf of the Shoosmith Sanitary Landfill that reiterated that the remaining constructed capacity is still being utilized under the current footprint

of the landfill. SCS, nor Shoosmith had any opposition to removing cells 27 and 28 (quarry) from the CVSWMP.

Subsequent to the public hearing on May 17, 2024, the CVWMA Board of Directors approved Resolution 24-19 Amendment 10 to the CVSWMP, unanimously to remove the quarry (cells 27 and 28) capacity of the Shoosmith Landfill from the regional Plan.

A resolution is attached for review and consideration and upon approval will authorize CVWMA to move forward with Amendment 10 to the CVSWMP.

## Proposed Amendment 11 to the Central Virginia Solid Waste Management Plan – Tri-Cities Sanitary Landfill

#### **Background:**

The Central Virginia Solid Waste Management Plan (CVSWMP or Plan) was prepared for the Central Virginia Waste Management Authority (CVWMA) and 13 local governments within the Authority's service area in accordance with the requirements and provisions of Regulations for Solid Waste Planning (9 VAC 20-130-10 et seq.). The CVSWMP provides an integrated solid waste management strategy for the region. The CVSWMP was originally approved by the Department of Environmental Quality (VA DEQ) August 20, 2004 for the period 2004-2024 and most recently updated and approved by DEQ, on October 29, 2021 for the period of 2019-2039. Virginia Solid Waste Regulations 9 VAC 20-130-175, Amendments to plans, paragraph A, requires a major amendment to the solid waste management plan for any addition or cessation of landfill disposal capacity. A major amendment to the CVSWMP includes a public hearing, approval by the CVWMA Board of Directors, approval by the Richmond Regional and Crater Planning District Commissions and ultimate approval by the VA DEQ.

The Tri-Cities Sanitary Landfill is a municipal solid waste landfill located at 390 Industrial Drive in the City of Petersburg. The landfill is permitted under Solid Waste Facility Permit Number 228 issued by the VA DEQ

This Landfill is no longer accepting waste and is in the process of closure. Meridian Waste, the owners of the landfill discontinued accepting waste in late 2018 and the solid waste permit was ultimately revoked by DEQ, and the landfill is currently in closure. There was approximately 500,000 tons of capacity remaining at the time of closure. This remaining capacity will be removed from the Plan by this amendment.

The CVWMA Board of Directors held a public hearing regarding this proposed Amendment 11 to the regional Plan to remove this landfill disposal capacity that is and will no longer be available to the region. Interested parties were encouraged to review the 2019-2039 Plan and to comment on the proposed amendment at the regular meeting of the CVWMA Board of Directors at 9:00am on Friday, May 17, 2024 in the Large Conference room on the first floor of 2104 W Laburnum Avenue, Richmond VA 23227. A virtual option for comments during the public hearing was also made available. No comments were received from the public before or during the hearing.

Subsequent to the public hearing on May 17, 2024, the CVWMA Board of Directors approved Resolution 24-20 Amendment 11 to the CVSWMP, unanimously to remove the remaining 500,000 tons of capacity of the Tri-Cities Sanitary Landfill from the regional Plan.

A resolution is attached for review and consideration and upon approval will authorize CVWMA to move forward with Amendment 11 to the CVSWMP.

### Environmental & Intergovernmental Reviews

In cooperation with State Agencies, PlanRVA routinely is requested to provide environmental and intergovernmental reviews. PlanRVA staff circulate the review requests among member locality staff for comments and questions prior to submitting a response to the requesting State Agency.

#### Environmental reviews can include:

- Environmental Assessments and Impact Reports Virginia code requires state agencies to prepare an environmental impact report (EIR) for each major state project.
- Coastal Consistency Determinations and Certifications Due to receipt of Federal funds or permits, proposed projects must prove consistency with the enforceable policies of Virginia's Coastal Zone Management Program.
- Groundwater Withdrawal Permits PlanRVA staff receives notice of Groundwater Withdrawal Permits in the Eastern Virginia Ground Water Management Area (GWMA). The eastern portion of PlanRVA is located in the Eastern Virginia GWMA. All jurisdictions in the Eastern Virginia GWMA are notified of pending permits as part of this process, therefore PlanRVA receives review requests for projects outside of the Richmond region. For more information about the Eastern Virginia GWMA see <a href="https://www.deq.virginia.gov/permits/water/water-withdrawal">https://www.deq.virginia.gov/permits/water/water-withdrawal</a>.
- Virginia Water Protection (VWP) Permits DEQ issues VWP Permits for activities related to the quality of surface waters in the Commonwealth including the filling, dredging, draining or excavation of wetlands, streams, or other state waters. Surface water withdrawals are also permitted through VWP permits.
- Virginia Pollutant Discharge Elimination System (VPDES) Permits DEQ issues VPDES permits to any person who discharges any pollutant into surface waters of the Commonwealth from a point source.
- Virginia Pollution Abatement Permit A VPA permit may be issued by DEQ whenever an owner handles waste and wastewater in a manner that does not involve a point-source discharge to state waters.

#### Intergovernmental reviews can include:

- State Agency grant applications for Federal funding, including:
  - CERCLA grant funds from US EPA (Superfund programming and site remediation)
  - Virginia Coastal Zone Management Program funding from the National Oceanic and Atmospheric Administration
  - Diesel Emission Reduction Act (DERA) State Clean Diesel funds from US EPA
  - Capitalization funds for the Virginia Clean Water Revolving Loan
     Fund for wastewater treatment facility improvements from US EPA
- FHWA Section 5310 funding for projects involving transit and mobility enhancements for seniors and individuals with disabilities.

#### The CTAC met on July 18<sup>th</sup>. The group discussed the following:

- RRTPO public outreach and engagement planned deliverables:
  - o General engagement and outreach
  - o Update Title VI plan
  - o Publish Annual Public Engagement report
  - o Support for Green Infrastructure Plan update
  - o Support for economic development, housing work
- CTAC Transportation Equity Work Group
  - o The RRTPO bylaws state the CTAC will be supported by a subcommittee called the CTAC Transportation Equity Work Group. Committee members will further explore at their next meeting how best to take advantage of this opportunity to explore issues around equity for the transportation disadvantaged.

**The TAC met on July 9<sup>th</sup>.** The group heard a presentation on Pathways to the Future – Scenario Planning Overview:

Pathways to the Future (P2F) is the regional exploratory Scenario Planning project which developed the Richmond region's first cross-discipline scenario planning tool to assist in planning for uncertain futures. P2F addresses the region's current and future needs related to transportation, community development, natural resources and emergency

preparedness through equitable strategies, effective public engagement, data collection and analysis.

The outcomes of the *P2F* scenario planning process will have a wide application to different planning areas (transportation, economic development, housing, environment, etc.). It will provide useful data and strategic planning input for the Richmond region at three levels of geography (regional level, jurisdictional level and at the sub-jurisdictional level). Among the primary benefits and values of this process is the robust and informative set of outputs to answer the "what if" questions about the future. The scenarios and findings of the study have a great utility in identifying potential long-term planning solutions.
