Martha Shickle, Executive Director, reported that the CVWMA requested the inclusion of amendments to the Solid Waste Management Plan for Central Virginia on this month's agenda.

The CVWMA is responsible for implementing solid waste management and recycling programs for 13 participating local governments in Central Virginia. As such, they are responsible for developing and submitting the region's Solid Waste Management Plan to the Virginia DEQ.

i. Proposed Amendment 10 to the Central Virginia Solid Waste Management Plan – Shoosmith Landfill

Kim Hynes, CVWMA Executive Director, came forward and explained the request for amendment 10 to the CVSWMP.

On motion by Jordan Stewart, seconded by Jim Holland, the members of the PlanRVA Commission voted to adopt the following resolution (voice vote):

WHEREAS, in accordance with the provisions of Section 10.1-1411 of the Code of Virginia, the Central Virginia Solid Waste Planning Area was designated by the Virginia Department of Waste Management as a planning area on May 31, 1991, and

WHEREAS, the Central Virgnia Solid Waste Planning Area is contiguous with and concurrent to the geographic boundaries of the Central Virgina Waste Management Authority (CVWMA) comprised of the following member jurisdictions: Cities of Colonial Heights, Hopewell, Petersburg, and Richmond, the Counites of Charles City, Chesterfield, Goochland, Hanover, Henrico, New Kent, Powhatan and Prince George and the Town of Ashland, and

WHEREAS, Section 9 VAC 20-130-30 of the Code of Virginia requires that Solid Waste Planning Areas develop comprehensive and integrated solid waste management plans that at a minimum consider and address all components of the following hierarchy: source reduction, reuse, recycling, resource recovery (waste-to-energy), incineration and landfilling, and

WHEREAS, the Richmond Regional Planning District Commission and the Crater Planning District Commission are designated as the entities responsible for the development and maintenance of the solid waste management plan for the central Virginia region; and,

WHEREAS, the plan horizon covers the 20-year period from 2024 through the year 2044; and

ii. Proposed Amendment 11 to the Central Virginia Solid Waste Management Plan – Tri-Cities Sanitary Landfill

iii. Proposed Amendment 12 to the Central Virginia Solid Waste Management Plan – East End Landfill

Environmental & Intergovernmental Reviews

In cooperation with State Agencies, PlanRVA routinely is requested to provide environmental and intergovernmental reviews. PlanRVA staff circulate the review requests among member locality staff for comments and questions prior to submitting a response to the requesting State Agency.

Environmental reviews can include:

- Environmental Assessments and Impact Reports Virginia code requires state agencies to prepare an environmental impact report (EIR) for each major state project.
- Coastal Consistency Determinations and Certifications Due to receipt of Federal funds or permits, proposed projects must prove consistency with the enforceable policies of Virginia's Coastal Zone Management Program.
- **Groundwater Withdrawal Permits** PlanRVA staff receives notice of Groundwater Withdrawal Permits in the Eastern Virginia Ground Water Management Area (GWMA). The eastern portion of PlanRVA is located in the Eastern Virginia GWMA. All jurisdictions in the Eastern Virginia GWMA are notified of pending permits as part of this process, therefore PlanRVA receives review requests for projects outside of the Richmond region. For more information about the Eastern Virginia GWMA see https://www.deq.virginia.gov/permits/water/water-withdrawal.
- Virginia Water Protection (VWP) Permits DEQ issues VWP Permits for activities related to the quality of surface waters in the Commonwealth including the filling, dredging, draining or excavation of wetlands, streams, or other state waters. Surface water withdrawals are also permitted through VWP permits.
- Virginia Pollutant Discharge Elimination System (VPDES) Permits DEQ issues VPDES permits to any person who discharges any pollutant into surface waters of the Commonwealth from a point source.
- **Virginia Pollution Abatement Permit -** A VPA permit may be issued by DEQ whenever an owner handles waste and wastewater in a manner that does not involve a point-source discharge to state waters.

Intergovernmental reviews can include:

- State Agency grant applications for Federal funding, including:

1. Among the six elements which one do you feel is impacted the most by transportation actions? Example(s)?

- Infrastructure: 18
- Environment: 1
- Housing diversity: 3
- Safe/healthy communities: 10
- Economic vitality: 18
- Equitable opportunity and choice: 8

Tallies reflect that some respondents chose more than one element.

Examples Comments

- For Infrastructure, respondents added:
 - o "Water, sewer, and roads drive economic development"
 - o "Must have a plan for future growth of commercial and housing development"
 - o "Public transportation is big for housing, safe/healthy communities, and economic vitality"
 - o "You need the facilities in place to be able to have the resources to create the environment"
 - "Road improvements capacity and congestion"
 - o "Interstate exchange allows for more roads/industrial/commercial development"
 - o "Transportation affects all of these, it is a linchpin that connects and creates all the elements"
 - o "Transportation impacts all of the six elements"
- For Housing Diversity, respondent added "People will have choices if they have access to good transportation."
- For Safe and Healthy Communities, respondents added:
 - o "Depends on mode I believe transit and bike/ped connections would have most impact"
 - o "Accidents reduction"
 - o "Safety pedestrian deaths are increasing, need safe routes to school, vehicle accidents; Health pollution, environmental justice, activity"
- For Economic Vitality, respondents added:
 - o "Transportation of people to their jobs, their personal activities, their purchasing is dependent on the ability to safety and easily access their communities"
 - o "Roads, bike, and ped are important you have to have infrastructure"
 - "A strong, well-connected community contributes to a thriving community, and a thriving community is attractive and desirable, promoting economic vitality, and strong economic vitality is reflective of a healthy community"
 - o "Where the roads take us to and from in the rural communities"
 - o "Connect people to jobs, hubs in the community, family. Gives the community the ability to address problems"
 - o "Limited and challenging public transportation"
 - "Within diverse communities, with socio-economic variances, transportation directly affects people's ability to get to work"
 - o "The ability to get to and from localities/businesses enables sustainable growth"
 - o "Access to jobs, housing, places to shop/eat, etc. Transportation or the lack thereof impacts movement"

- o "Economic vitality is the hub of all the others"
- For Equitable Opportunity and Choice, respondents added:
 - o "Access to transportation, quality of life (costs, choice to live), economic investments/employment, growth (population)"
 - o "Have to be able to get to jobs, shopping, medical, services"
 - "Extends to others (especially economic vitality) more options on where to live and work if you are able to access reliably"
 - o "Multi-modal"

Question 1 Summary

Respondents most frequently selected infrastructure and economic vitality as the elements most impacted by transportation actions. In considering the strong connection between economic vitality and transportation actions, one respondent noted "Transportation of people to their jobs, their personal activities, their purchasing is dependent on the ability to safety and easily access their communities." Many respondents also selected the Safe and Healthy Communities and Equitable Opportunity and Choice elements; Environment and Housing Diversity had the fewest selections. All elements received at least one selection, and many comments noted linkages among the elements and transportation policy - one respondent noted: "Transportation affects all of these, it is a linchpin that connects and creates all the elements."

2. Among the six which one do you feel is impacted the least?

• Infrastructure: 2

Environment: 12

• Housing diversity: 17

• Safe/healthy communities: 10

• Economic vitality: 2

• Equitable opportunity and choice: 3

Tallies reflect that some respondents chose more than one element.

Written comments examples

- For Infrastructure, respondent added "We create things based on what we want/need, not based on transportation per se."
- For Environment, respondents added:
 - o "Still a long way from non-car transportation at community level how to make this a more attractive choice?"
 - "Generally don't have any major environmental issues"
- For Housing Diversity, respondent added "Transportation can be used to increase diversity but of the six, I see this as the least impacted."
- For Safe and Healthy Communities, respondents added:
 - o "Maybe safe/healthy communities, but people need good transportation to get to doctor appointments, hospitals"
 - "Traffic calming, speed reduction"
 - o "Because I think VDOT does a good job keeping the roads safe and our law enforcement agencies are out of our realm of responsibility"
 - o "More local resources, e.g., addressing access to food, healthcare, etc. within each community so that residents do not have to travel for those services"

- For Economic Vitality, respondent added "Trains, planes and shipping are huge economic components. Cars are expensive, but typically the only option."
- "It's hard to say that one is not important or is less important. They all play a part and we have the responsibility to serve all factors."

Question 2 Summary

Respondents most frequently selected housing diversity as the element least impacted by transportation actions. One respondent noted of the Housing Division choice: "Transportation can be used to increase diversity, but of the six, I see this as the least impacted." Environment and Safe and Healthy Communities were also frequent selections for this question. Perhaps reflecting the thoughts of some others in the room, one respondent noted: "It's hard to say that one is not important or is less important. They all play a part and we have the responsibility to serve all factors."

3. Among the six which do you feel deserves the most immediate, short-term attention from the transportation community?

- Infrastructure: 16
- Environment: 1
- Housing diversity: 3
- Safe/healthy communities: 15
- Economic vitality: 7
- Equitable opportunity and choice: 11

Written comments examples

- For Infrastructure choices, respondents added:
 - o "The declining state of our infrastructure, i.e., roads, bridges is at a critical point that requires attention"
 - o "Keeping up with the pace of our growing and changing community to set-up for long-term success being thoughtful and intentional"
 - o "Electric vehicles, charging infrastructure"
 - o "Roads traveled with less backup time and bridge and road repairs like beltways and HOV lanes"
- For Environment, respondent added "Top source of greenhouse gas emissions apply for federal dollars, easier near-term actions."
- For Housing Diversity, respondents added:
 - o "Transportation investments targeted to growth nodes"
 - o "We need public servants to be able to live in the communities they serve"
- For Safe and Healthy Communities, respondents added:
 - o "Sidewalks, bike lanes, safe crossings, slow speeds"
 - o "In today's environment, this is a priority"
 - o "The growth of traffic and size of vehicles on narrow roads"
 - "All of these are important and serve a need. A part of the planning process is to create the best environment for the communities we serve – we need to work toward all."
 - "Develop safer roads for current/future development"
- For Equitable Opportunity and Choice, respondent added "To ensure everyone has access to the same level of service."

Question 3 Summary

Infrastructure and Safe and Healthy Communities were the top selections for the elements deserving the most immediate short-term attention from the transportation community. Written responses for those selecting infrastructure noted the need to both keep up with maintenance of existing infrastructure and to keep up with growth and new development as well as changing needs such as electric vehicle infrastructure. Several selecting Safe and Healthy Communities added comments about the need to improve the safety of various modes of transportation to create the best environment within our communities. Equitable Opportunity and Choice was also a frequent response to this question, and all elements received at least one selection, reflecting the range of priorities across the group.

4. Reflecting on the six elements, do you believe that there is an equally important topic that is not included?

The three most frequently listed were...

- Education (with one respondent suggesting "consider a regional plan that includes public/private/personal homeschool; consider model like the CVTA for education")
- Community Engagement
- Public Safety

Many specific aspects of transportation planning and policy were listed...

- Multi-modal transportation
- Multi-modal facilities air, rail, water, road, pipeline
- Multi-modal connectivity
- Convenient and affordable access to transportation hubs via BRT or light rail, which would facilitate regional tourism
- Perhaps increasing the safety elements of transportation
- Safety/security of the transportation system
- Accessibility
- Reliability
- Sidewalks from CVTA
- Convenience/efficiency of the transportation system
- Efficiency

Other items listed included...

- Workforce development, Talent development
- The relationship with other parts of the region, regional cooperation/collaboration funding
- Housing availability at all levels
- Mental Health
- Tourism
- Recreation and perspective on community identity
- Land Conservation
- Green Initiatives/Sustainability
- Disaster preparedness and/resilience
- Funding sources, resources
- Community volunteerism and engagement with charitable agencies
- Diverse communities
- Community
- Identify tomorrow's needs, i.e., what will be materially different in the future (compared to today)
- Remote work

Several respondents indicated that the six elements listed on the sheet covered what they considered the important topics for the region.

The \$7.5 million in dedicated Fall Line funding from the 2024 State Budget should be allocated to the Fall Line: Kanawha Plaza (5A-R) project in the amount of \$4.5 million and the Fall Line Trail: Route 1 (Food Lion Falling Creek Wayside) UPC 115415 project in the amount of \$3 million.
- The Authority voted to approve the Fall Line Trail Wayfinding Plan, which includes a comprehensive signage/wayfinding package.
