CALL TO ORDER

A draft of the final report is expected to be ready in early to mid-October. There was discussion about adding a non-technical explanation of Vision Zero to provide an understanding of what it is to those who aren't familiar. This would include information on equity and collaboration efforts. Group members discussed highlighting the tools and resources and making them available and easily accessible to interested parties. The group members explored the idea of including a target date for reaching zero traffic related deaths and serious injuries. into the draft. The Mission Statements states 2030.
