

Screening and Development of the Universe of Transportation Projects

Staff used the local and regional Issue Inventory spreadsheet as approved by the LRTP-Advisory Committee (AC) in their May 28 meeting as the starting point for the screening and development of the regionally significant transportation projects within the RRTPO's Metropolitan Planning Area (MPA) Boundary. Firstly, the Issue Inventory spreadsheet was spilt into different spreadsheets by different transportation modes - Active Transportation, Transit/Park and Ride, Freight/Rail/Multimodal and Highways. The Highway list was further broken down by the localities. Bridges and Interstate, Freeways and Multi-jurisdictional issues are listed separately. Please see the 'Universe of Issues for Screening' spreadsheet for details.

Staff have initiated the development of transportation projects for issues which have a project solution based on a completed or on ongoing studies and plans (to the extent possible). The projects as developed in those plans were then screened based on the 'Project Inclusion Guidelines' for ConnectRVA 2045. For issues which came out of the RRTPO Congestion Management Process, Richmond Tri-Cities Travel Demand Model runs, RRTPO 2020 Structures Inventory and Assessment Report, and local comprehensive/small area/transportation plans, the projects have not been developed yet. Since there is a lot of overlap of the issues some of them have already been addressed. Staff will work with VDOT, DRPT, locality representative and subject-matter experts in AC to develop and screen these projects.

- Public Comments Out of 135 issues, 50 qualify for ConnectRVA 2045 based on the Project Inclusion Guideline. (Most of them have been covered by other established issues).
- Policy Program Out of 272 Issues, 18 qualify for ConnectRVA 2045 based on the Project Inclusion Guideline. Most are rail projects.



Unfunded Projects – 175 Unfunded projects based on Plan2040 and Smart Scale (Rounds 1-3). 89 Projects qualify for ConnectRVA 2045 based on the Project Inclusion Guidelines. (Some of the projects may be listed multiple times and some may have secured funding).

Please review the spreadsheet as a Project Champion or based on the area of expertise and provide comments. If you have already developed a project addressing an issue, please also note that. For a project to be in the LRTP we would require at the minimum the location details the project, anticipated project cost (capital, maintenance and operations) and time frame for which it is phased for completion. Complex projects like interchanges would require some kind of conceptual sketch. The project should also qualify based on the Project Inclusion Guideline.

The product of this exercise will be a spreadsheet with all the projects with detailed description and anticipated project cost. The Champions should also look into factors like availability of right of way or if the relocating of utilities is needed. Finally, there should be a political will of the locality to move forward with the project.

Once the list of projects is completed and vetted by the AC it would be posted online for a two-week formal public review period. After the completion of public review period it will come back to the AC for approval. Based on the timeline we are scheduled for approval of the list of transportation projects by October-November timeframe.
