FY24 First Quarter Activity

FY24 First Quarter Report

- Prepared framework for the Community Transportation Advisory Committee (CTAC) to have an expanded community engagement role; developed plan for CTAC to work with the Community Engagement Manager as one of the agency's primary drivers for public engagement, starting with the revision/update of the Public Engagement Plan in 2024.
- Created Marketing analytic charts for the RRTPO engagement report.
- Jointly hosted with Chesterfield County the quarterly gathering of the localities' planning directors to exchange ideas on a variety of planning topics, including Short Term Rental regulations, major project updates, solar siting agreements, etc.
- Continue to track and assess applicability of Federal and State competitive grant programs for infrastructure improvements.
- Assist Charles City County with the kick-off of the Route 106 corridor study with VDOT.
- Responded to a request from Hanover County related to "jake" braking and researched possible authority for a locality or VDOT/DMV to regulate.
- Produced several maps of the Route 106 Corridor for Charles City County. They
 included the following information:
 - o 2,000-foot corridor buffer over aerial photography
 - o parcels along Route 106 within the buffer
 - o parcels at least 11 acres in size fronting Route 106
 - o parcels in the corridor under consideration for rezoning
- Continued work with BizSense about collaboration on development project mapping for applications in other program areas like scenario planning, the travel demand model, transit planning, active transportation, resilience, intermodal planning, and the long-range transportation plan.
- Coordinated with Tri-Cities Area MPO (TCAMPO) and VDOT to adjust the Richmond/Tri-Cities Metropolitan Planning Area (MPA) boundary because of the changes in Census Block geography from Census 2010 to Census 2020. This will be reviewed at the TAC meeting in October.
- Coordinated with New Kent County and VDOT on a proposed CLRP amendment to add the Rt 106 interchange improvements project and remove several other projects. This approval is necessary for IAR approval. The amendment will be reviewed at the TAC meeting in October.
- Reviewed existing LRTP document scope in preparation for upcoming update process.
- Facilitated Scenario Planning Advisory Committee (SPAC) meeting.
- Assisted with an environmental screening for the Richmond to Raleigh higher speed rail project completed by the Virginia Passenger Rail Authority (VPRA) and NC DOT for updates/changes since the 2015 Environmental Impact Statement.
- Updated the summary of regional transportation services and providers to include adjacent providers such as Virginia Regional Transit and Williamsburg Area Transit Authority.

- Presented draft report for West Broad Street BRT Analysis to RRTPO Policy Board
- Continued role with CVTA Fall Line Work Group, assisting in the CVTA Wayfinding plan, coordinating with the contractor to complete a checklist of needed tasks as part of the planning process.
- Met with local partners to continue discussion of potential long-term plan for maintenance and management of Fall Line.
 Assisted with a mobility audit of Petersburg neighborhoods with regional partners that included a tour of the Appomattox River Trail and potential Fall Line destinations.
- Assisted the Virginia State Office of Trails with a public survey in advance of the Statewide Trails plan.
 Interview for <u>Axios article about the spread of e-bike incentive programs</u> nationwide in connection with the E-Bike Incentive Project.
- Updates on projects contributing to the regional Active Transportation network continue to be made to the BikePedRVA 2045 Information Hub.
- Assisted the VDOT Statewide Bicycle and Pedestrian planner to hold the quarterly Bicycle and Pedestrian Advisory Committee meeting at the PlanRVA offices on July 25. There were 35 in-person attendees and approximately that many more online.
- Participated in a mobility audit of Petersburg neighborhoods with regional partners that included a tour of the Appomattox River Trail and potential Fall Line destinations.
- Staff scheduled more meetings with historians to record segments of oral history of the Ashland Trolley Line.
- DOF Urban Heat Mapping project preliminary results were generated in Google Earth Engine. Daytime Surface Temperature analysis was completed. Maps were generated that show average warm-month, daytime surface temperatures across the entire region for every year from 2014-2022; a combined 5-year average from 2017-2022; and a delta temperature change between 2014 and 2022. Work began on nighttime temperature analysis. Nighttime temperature analysis began, utilizing Python and data from ISS ECOSTRESS. Data collection for Phase II (InVEST model analysis) began.
- SHSP Critical Infrastructure Mapping began and continued literature review and initial data scoping
- Homeward Partnership Conducted the second deployment of GIS tools for the July Point-In-Time Count, through our piloted partnership with Homeward. Built a new survey and Esri Dashboard, and trained all PIT volunteers on using the tools. We were able to expand the functionality of the GIS tools provided this time, which enabled the Daily Planet to track, in real-time, individuals marked as in need of medical attention by the field surveyor, and to deploy their medical response team to the exact location of the individual immediately.
- Climate Pollution Reduction Grant awarded the full \$1 Million grant.
- Prepared a funding application for a Regional Catastrophic Preparedness Grant (RCPG) to plan for a network of climate hubs and associated catastrophic emergency care in the Richmond MSA. The plan will be created in partnership with the Emergency Management Alliance of Central Virginia and the Greater Richmond Continuum of Care.

- Pluvial Flooding Modeling the DEVELOP Team completed their pluvial flooding project and presented their findings at Langley Research Center. The project was also chosen as a highlight project for DEVELOP Day. PlanRVA's Resilience Planner co-presented the project at NASA HQ in Washington, DC.
- Completed development of a Pillars of Resilience handout for public education about PlanRVA's Resilience Work.
- Prepared and submitted two FY24 FY27 TIP amendments, which were approved by the Policy Board.
- Presented draft project list for illustrative projects section to be added to FY24 FY27 TIP.
- Coordinated with FHWA/VDOT to review Reconnecting Jackson Ward planning grant; determined project must be reflected in the UPWP, not the TIP. Prepared UPWP amendment to add an appendix for the Reconnecting Jackson Ward planning grant based on coordination with VDOT and FHWA
- Reviewed 19 Transportation Alternatives pre-applications for consistency with regional planning and prepared a resolution of endorsement.
- Researched Carbon Reduction Program (CRP) policies of peer agencies nationally to develop recommendation for program implementation and prepared recommendation for August TAC meeting; revised Regional Funding Framework to incorporate recommended TAC revisions to include Carbon Reduction Program (CRP).
- Developed draft FY25 FY30 regional funding schedule; coordinated with CVTA and Smart Scale schedules to ensure tentative funding recommendations for both programs are available for Smart Scale pre-application window
