The RRTPO LRTP Advisory Committee meeting was held by electronic communication means as set forth by the April 22, 2020 actions of the General Assembly in response to the continued spread of novel coronavirus, or COVID-19. The technology used for this meeting was a web-hosted service created by Zoom and YouTube Live Streaming and was open and accessible for participation by members of the public. ### Call to Order:

The LRTP Advisory Committee Chair, Andrew Pompei, presided and called the March 25, 2021 LRTP meeting to order at 9:00 a.m.

#### 1. Consideration of Amendments to the Agenda

There were no requested changes to the meeting agenda. Seeing and hearing no objections, the agenda was approved by acclamation as presented.

#### 2. Approval of February 25, 2021 LRTP-AC Meeting Summary

There were no comments or corrections to the February 25, 2021 LRTP-AC meeting summary. The LRTP Advisory Committee unanimously approved the meeting summary of the February 25, 2021 meeting by acclamation as presented.

#### 3. Public Comment Period

There were no requests to address the LRTP Advisory Committee.

#### 4. LRTP Process Update Task 3: Planning

a. Universe of Projects – First Look

RRTPO staff completed the final draft of the regionally significant projects across all modes which are called the 'Universe of Projects". These projects were screened based on the Project Inclusion Guidelines and the list was distributed to the committee members on March 19<sup>th</sup>. Staff thanked all the Champions for reviewing the projects in detail and providing staff with the necessary corrections. After a review of the public comments received on the Universe of Projects list, a discussion on the recent public engagement efforts took place, and it was recommended that the RRTPO extends the public comment period for the draft Universe of Projects, made available for public comment on March 8, 2021. The public comment period for the Draft Universe of Projects was to complete on March 23, 2021. This extension is being made in response to public requests for additional review time.

On motion of Champe Burnley, seconded by Ben Campbell, the Richmond Regional Transportation Planning Organization (RRTPO) LRTP Advisory Committee approved the following resolution (17-Y 4-N 2-A; see Appendix A):

**RESOLVED**, that the Richmond Regional Transportation Planning Organization (RRTPO) LRTP Advisory Committee extends the public comment period for the Universe of Projects through April 15, 2021.

Sulabh Aryal, Planning Manager, provided a brief summary on the changes made to the Universe of Projects for the final draft and recapped the transportation needs by project type. Projects in this list will be evaluated, scored, ranked and prioritized to be in the 'Constrained List of Projects. Projects that do not make the cut will be listed in the 'Vision List of Projects'. Endorsement of the Universe of Projects by the committee was requested:

On motion of Kathryn Benedict, seconded by Joseph E. Vidunas, the Richmond Regional Transportation Planning Organization (RRTPO) LRTP Advisory Committee approved the following resolution (21-Y 0-N 2-A; see Appendix A):

**RESOLVED**, that the Richmond Regional Transportation Planning Organization (RRTPO) LRTP Advisory Committee approves the Universe of Projects as presented and authorizes staff to begin the testing process to score, rank, and prioritize the Universe of Projects into a refined draft cost constrained project list.

**FURTHER RESOLVED**, that the RRTPO reviews additional comments received after the extended public review period closes and works with the project sponsors and the Champions to determine the impact of these comments on the Universe of Projects list.

#### 5. LRTP Process Update Task 4: Programming

a. Universe of Projects: Scoring and Evaluation – Update and Needs Staff has been working on developing revenue estimates for the implementation of the projects in the ConnectRVA 2045 plan based on revenue projections provided by VDOT and DRPT. Additionally, staff obtained licensed copies of CUBE, a comprehensive, powerful, script driven software platform for building and applying complex models and simulations of transportation land use systems, provided by VDOT to conduct <u>model runs</u> on all of the projects. Staff will compile the data and develop a database system.
