The RRTPO LRTP Advisory Committee meeting was held by electronic communication means as set forth by the April 22, 2020 actions of the General Assembly in response to the continued spread of novel coronavirus, or COVID-19. The technology used for this meeting was a web-hosted service created by Zoom and YouTube Live Streaming and was open and accessible for participation by members of the public. #### Call to Order:

The LRTP Advisory Committee Chair Andrew Pompei presided and called the June 24, 2021 LRTP AC meeting to order at 9:02 a.m.

#### 1. Consideration of Amendments to the Agenda

There were no requested changes to the meeting agenda. Seeing and hearing no objections, the agenda was approved by acclamation as presented.

#### 2. Approval of June 2, 2021 LRTP-AC Meeting Summary

There were no comments or corrections to the June 2, 2021 LRTP-AC meeting summary. The LRTP Advisory Committee unanimously approved the summary of the June 2, 2021 meeting by acclamation as presented.

#### 3. Public Comment Period

There were no requests to address the LRTP Advisory Committee.

#### 4. LRTP Process Update Task 4: Programming

a. Constrained Plan Budget Recap Staff provided a quick recap of the constrained budget development process. The planned investments cover the entire plan period from 2022 through 2045 with a budget of approximately \$20.5 billion. The investments were divided among programmatic expenses (maintenance and administrative operations), local capital investments, and regional projects. \$670M (of the \$6.195 billion in the regional pot) are already committed to regionally significant projects through the six-year improvement plan; that leaves \$5.525 billion to develop the constrained plan.

#### b. Public Comments: Constrained Lost of Projects

The public comment period for the staff recommended constrained list of projects ran from June 2, 2021 through June 17, 2021. A total of 150 comments were received through direct emails, the Wikimap of potential projects, and directly on the ConnectRVA 2045's website. A compilation of the comments was provided to the committee members. Based on the public comments received and meetings with the Project Champions, staff revised the staff constrained list of projects and recommended approval of the draft Constrained List of Projects as presented.

# c. Staff Recommended Constrained List of Projects On motion of Todd Eure, seconded by John Leonard, the Richmond Regional Transportation Planning Organization (RRTPO) ConnectRVA 2045 Advisory Committee recommended RRTPO Policy Board approval of the following resolution as presented (19-Y 1-N 0-A; see Appendix A):

**RESOLVED**, that the Richmond Regional Transportation Planning Organization ConnectRVA 2045 Advisory Committee approves the draft Constrained List of Projects.

#### 5. LRTP Process Update Task 5: Evaluation

a. Air Quality Conformity

Air Quality Conformity is a federal requirement that requires MPOs to ensure that the projects in the LRTP and TIP are in compliance with federal and state regulations and contribute to the air quality improvement goals as stated in the 1990 Clean Air Act Amendments. The Richmond Interagency Consultation Work Group will convene on July 7, 2021 and is tasked with developing the draft Regional Conformity Assessment for the ConnectRVA 2045 Long-Range Transportation Plan (LRTP) and Fiscal Year 2021-2024 Transportation Improvement Program (TIP). A 15-day public review and comment period on the draft Regional Conformity Assessment report will take place in July before the RRTPO Policy Board will be asked to approve the report in August.
