STATEMENT REGARDING VIRTUAL MEETINGS

CALL TO ORDER

The Richmond Regional Transportation Planning Organization (RRTPO) Technical Advisory Committee (TAC) Vice Chairman, Sharon Smidler, presided and called the March 21, 2022, RRTPO TAC meeting to order at 11:00 a.m.

ATTENDANCE ROLL CALL & CERTIFICATION OF MEETING QUORUM

Janice Firestone, Program Coordinator, took attendance by roll call and certified that a quorum was present.

1. Consideration of Amendments to the Action Meeting Agenda

There were no requested changes to the meeting agenda. Seeing and hearing no objections, the March 21, 2022, agenda was approved by acclamation as presented.

2. Open Public Comment Period

There were no requests to address the Technical Advisory Committee.

3. STBG/CMAQ Program Development FY23-28 Draft Allocations

Myles Busching, PlanRVA, presented this item to the committee. Committee members had questions and Mr. Busching clarified that the new projects were selected using the scoring guidelines after updated budget figures were received showing a 17-18% funding increase in RSTP and a 13% funding increase in CMAQ.

Several projects with large deficits were not funded in the draft RSTP allocations plan. These projects had cost increase of which the sponsors were not aware and for which no funding request was submitted. These projects were discussed in detail.

Sharon Smidler made a motion, seconded by Austin Goyne, to fund the three existing RSTP projects with shortfalls that VDOT submitted revised estimates for before funding new projects.

Barbara K. Smith offered a friendly amendment to have staff look into funding the existing projects with shortfalls, then existing projects after that, and bring a draft back to the TAC to take action on.

There was a discussion about submitting a draft to meet the deadline and submitting an amendment later. After further discussion, Vice Chair Smidler declined the friendly amendment, and the motion was voted on and passed as originally stated (see Appendix A).

4. TAC Member Comments

There were no member comments.

5. Next Meeting: April 12, 2022

Vice Chair Smidler noted that the next regular RRTPO TAC action meeting is scheduled for April 12, 2022, beginning at 9:00 a.m.
