### Six-Year Improvement Program (SYIP) Development

- The CTB approved the FY24-29 SYIP of anticipated projects and programs at their June meeting.
  - Includes SMART SCALE Round 5 projects approved at the May CTB meeting.

### The Fall Line

- VDOT Design-Build Packages
  - DB#1 (Holly Hill Rd to Walder Ln; includes Chickahominy River crossing, UPC 121374)
    - Advertised in December 2022
    - Awarded in April 2023
    - Construction is anticipated to begin in fall 2023
  - DB#2 (Patton Park to W Hundred Rd/Chester Linear Park, UPC 121511)
    - Survey and RFP development are underway
    - Alignment at southern terminus is not yet finalized; VDOT is coordinating with VSU and navigating historic resources
    - Advertisement is anticipated for late 2023, but is subject to change depending on resolution of alignment/historic resources concerns
    - Ongoing discussions with CVTA and impacted localities; presentation to FLT working group 8/2 (presentation can be provided)
  - DB#3 (W Hundred Rd to Falling Creek/Food Lion)
    - Beginning to develop draft SPA agreement – will be contingent upon decisions made with resolutions of DB#2 challenges
    - Advertisement and Award to follow approximately 9-12 months after DB#2

### I-64 GAP Widening – Design-Build Projects

- Segment A – MM 204.9 to MM 215.6 in New Kent County (UPC 122805)
  - Request for Proposals (RFP) released in March
  - Design-Build contract is expected to be awarded in the fall of 2023
  - Estimated completion of this section is spring / summer 2027
- Segment B – MM 215.6 to MM 224.3 in New Kent County (UPC 123831)
  - VDOT anticipates releasing an RFP for Segment B in the summer of 2024
  - Estimated completion of this section is spring / summer 2028
