The Fall Line

- VDOT Design-Build Packages
 - DB#1 (Holly Hill Rd to Walder Ln; includes Chickahominy River crossing, UPC 121374)
 - Advertised in December 2022
 - Awarded in April 2023
 - Construction is anticipated to begin in fall 2023
 - DB#2 (Patton Park to W Hundred Rd/Chester Linear Park, UPC 121511)
 - Survey and RFP development are underway
 - Alignment at southern terminus is not yet finalized
 - VDOT is navigating historic resources
 - VDOT is coordinating with CVTA and impacted localities
 - VDOT presented to FLT working group 8/2 (presentation can be provided)
 - Advertisement is anticipated for late 2023, but is subject to change depending on resolution of alignment, funding and historic resources concerns
 - DB#3 (W Hundred Rd to Falling Creek/Food Lion)
 - Work on DB#3 is on hold until alignment revisions and budget/funding for DB#2 are resolved
 - Advertisement and Award dates to be solidified once funding is secured

I-64 GAP Widening - Design-Build Projects

- Segment A MM 204.9 to MM 215.6 in New Kent County (UPC 122805)
 - o Request for Proposals (RFP) released in March 2023
 - Design-Build contract is expected to be awarded in the fall of 2023
 - Estimated completion of this section is summer 2027
- Segment B MM 215.6 to MM 224.3 in New Kent County (UPC 123831)
 - VDOT anticipates releasing a RFP for Segment B in the summer of 2024
 - Estimated completion of this section is spring / summer 2028
- Segment C MM 224.3 to MM 233.3 in James City County/Hampton Roads District (UPC 123129)
 - o VDOT anticipates releasing RFP for Segment C in November 2023
 - Estimated completion of this section is November 2027
