The Virginia Department of Transportation will hold duplicate meetings to share information about the proposed location of the Fall Line Trail and alignment refinements to the corridor and receive public input. The meetings are scheduled as follows:

Find out about the proposed location of the Fall Line Trail and alignment refinements to the corridor for a multi-use trail within Chesterfield, Hanover and Henrico counties, as well as the cities of Colonial Heights, Petersburg and Richmond, and the Town of Ashland.

Review meeting materials and give your input on the proposed Fall Line Trail alignment, extending from the City of Petersburg to the Town of Ashland. The alignment was initially identified in VDOT's February 2020 *Ashland to Petersburg Trail Study*. Since the completion of the study and the identification of the preferred corridor, a number of alignment refinements have been incorporated into the corridor.

Each meeting will be held in an open-house style format with no formal presentation given and attendees are encouraged to arrive at any time during the open-house window. VDOT representatives will be present to discuss the alignment and answer questions.
