SMART SCALE – Round 5 (FY22 – FY27 SYIP)

- Final application period closed August 1 and all final applications have been submitted
 - Richmond District had 90 final applications (412 submitted statewide)
- Validation is underway
 - Richmond District Planning will facilitate all communication and coordination with applicants regarding SMART SCALE validation and scoring
 - VDOT staff appreciates the coordination that your staff is affording as we go through this process
- Scoring is anticipated to be completed in December

The Fall Line

- VDOT Design-Build Packages
 - The northern section design-build (DB) contract is on schedule for advertisement by the end of Calendar Year 2022
 - VDOT / CVTA Standard Project Agreement (SPA) for the northern section was presented to the CTB in July; action is anticipated at the September CTB meeting
 - The southern section DB contract is on schedule for advertisement by mid-2023
