Overview

- SMART SCALE is the state's prioritization process for transportation construction funding
- Regional bodies, like RRTPO, are eligible to submit projects on Corridors of Statewide Significance (COSS) and the Regional Network (RN)
- Due to the size of the region, RRTPO can submit 10 applications
- Two additional pre-applications allowed (total: 12)



Candidate Pool

- Staff evaluated nearly 40 projects for potential submission
- Sources included
 - RSTP/CMAQ applications
 - CVTA regional applications
 - SMART SCALE Round 4 applications
 - Locality requests


