Submitted Projects

- Richmond Signal System Phase III (UPC 105890)
 - Project base estimate has increased
 - Funding would allow for 1 additive to be funded
- Brook Rd & Hilliard Rd Trail (UPC 118153)
 - Fall Line project
 - PE start funded for FY24
 - Funding would allow PE start this year



Staff Recommendation

- Staff recommends Brook & Hilliard trail receive the unmatched funding & additional matched funds
- Signal project already received \$1.02M additional CMAQ in FY21 to cover cost increases
- Trail request has no cost increase, advances start
- Sufficient balance from closeouts to fully fund PE
