- Met from October 2020 to April 2021
- Voted at April meeting to forward draft guidelines to TAC for consideration
- Draft presented at May TAC meeting
- Comments requested from TAC members



# Major Goals of Update

- Update scoring to reflect LRTP goals & measures
- Incorporate TA Set-Aside program
- Better define the use of RSTP and CMAQ funds for leveraging to support CVTA and Smart Scale applications
- Improve TPO project tracking capacity



#### TAC Comments

- Comments were requested by May 26<sup>th</sup> to include with TAC agenda and draft document
- Minor changes to the document were incorporated into the draft or handled in implementation
- More substantial changes were left out of the draft for TAC discussion



## Minor Changes

In Draft/Administrative

- Change "RSTBG" to "STBG" to match FHWA and other MPOs
- Clarify application limit applies to new projects only
- Add link to functional classification map
- Clarify TA scoring (normalization)
- Simplify the allocation/programming guidance
- Reword overruns to allow flexibility during CN
- Remove 1-year notice re: meeting obligation requirement with notice ASAP



## **Substantive Comments**

**Proposed Only** 

- Reduce large locality application limit from 10 to 8
- Include obligations and expenditures with quarterly reports



## Requested Action

Recommendation on the following resolution

**RESOLVED**, that the Richmond Regional Transportation Planning Organization (RRTPO) Policy Board adopts the Regional Project Selection and Allocation Framework for the allocation of Surface Transportation Block Grant (STBG), Congestion Mitigation and Air Quality (CMAQ), and Transportation Alternatives (TA) Set Aside funds.

**FURTHER RESOLVED**, that the RRTPO Policy Board rescinds the Richmond Area MPO RSTP and CMAQ Project Review, Selection, and Funds Allocation Process.
