# Safety Performance Measures

In 2017 the safety performance measures workgroup established safety rate reductions which were more ambitious than the rates set by VDOT.

The guiding principle in setting the rates was a vison of achieving zero fatalities by 2040.

The RRTPO has submitted these rates each year since 2017.

### Asset Condition and System Performance Measures

There are nine Asset Condition and System Performance Measures required under MAP 21 and the FAST Act.

The methodology for setting targets for Asset Condition and System Performance Measures is a data intensive process best left to VDOT.

The RRTPO reports these targets biennially. There is no penalty for MPOs missing targets.
