Current Work Efforts Update – Item 5.c.

ConnectRVA 2045 Long-Range Transportation Plan

Following project scoring and discussions with project champions, the constrained list of projects was presented to RRTPO Policy Board for review and approval at their July 1 meeting. The requisite VDOT Air Quality Conformity public review process is also now underway. Staff continues to work on the full *ConnectRVA 2045* draft document, incorporating technical reports, and preparing for an active in-person and virtual public engagement process from August 16 through September 15.

Ashland Trolley Line Trail Study

Staff continues to work with the National Park Service's Rivers Trails and Conservation Assistance Program to explore the opportunity for adding the skills of an NPS public historian for greater interpretation of the trolley line's former role in community connections through signage and self-guided walking tours. Plans are underway for a September field trip to the corridor with NPS staff. Two story maps for the project illustrate the importance and potential for the 14-mile Trolley Line Trail, now a segment of the Fall Line Trail, and include history of the trolley line and a design sketchbook.

Regional Bicycle and Pedestrian Plan Update

Working with regional partners, staff continues to make additions and revise the interactive GIS story map data, project list, and foundational elements for the plan. The draft plan entitled *BikePedRVA 2045* including recommendations for priority projects to fulfill the regional network was presented to the steering committee for the plan on July 14. This plan is being prepared concurrently with *ConnectRVA 2045* as a major update to the 2004 Richmond Regional Bicycle and Pedestrian Plan. The Complete Streets toolbox or illustrated <u>story map</u> continues to be updated as one resource intended to implement *BikePedRVA 2045*.

Active Transportation Work Group (ATWG)

In addition to the regular quarterly meetings, staff continues to support Henrico staff on the County's ATWG and efforts to develop the bicycle and pedestrian chapter of the county's comprehensive plan. Staff also assists the East Coast Greenway Alliance (ECG) on potential designations of segments of the future route of the trail through the Richmond region and during quarterly ECG council meetings.

Public Transportation Work Group

The RRTPO Public Transportation Work Group wrapped up its support in the development of the GRTC Regional Transportation Plan. The draft plan was approved by the CVTA on June 25th.

Vision Zero Work Group

The RRTPO Vision Zero Work Group is working with VDOT and their consultant on a regional action plan. The data collection and analysis kicked off with a work group meeting on May 13th and will progress for the next few months, with the next meeting scheduled for July 29th. This action plan will be a great resource for member localities

as they position for safety improvements around the region. A schedule for completion of the plan is being developed.

Rural Transportation Advisory Committee (RTAC)

Staff has provided road network resiliency mapping and data to help the four (4) rural localities which have made up RTAC over the years of the Rural Transportation Program to consider long-term resiliency in their own planning and prioritization for roadway and bridge/culvert improvements. This data will help them work with VDOT to ensure better service to populations vulnerable to flooding. The data has also been useful throughout the Richmond region to assist in measuring "environmental resiliency" performance for project scoring through the LRTP process. Funding opportunities for implementing flood prevention measures, addressing hazard mitigation, and coastal resiliency have also been shared with RTAC.

Staff will work with the four rural members of the RRTPO to prepare for the October 2021 full transition to urban designation in the RRTPO.

Report

The following is a brief report on major discussion items from the July 15, 2021 CTAC meeting.

<u>Disability Inclusive Transportation-Assessment of First/Last Mile</u> <u>Conditions in the Richmond Region</u>

Rebekah Cazares highlighted the purpose of her study, which was to increase access to public transportation services in the Richmond region for individuals with disabilities. Examples of first and last mile barriers to public transit service were presented, along with estimates of the disability demographics in the region. All 240 census tracts in the region were analyzed with regard to their accessibility to transit, and a detailed case study was undertaken of a census tract having a high score on factors that limit access to transit. Recommendations to address first/last mile barriers to accessing transit were developed, along with a proposed implementation timeline.

<u>Virtual Tour of the VDOT Richmond District Traffic Operations Center</u>

Ed Correa of VDOT reviewed various aspects of the planning, construction and operation of a new Traffic Operations Center at the VDOT Richmond District Complex. In addition to reviewing the timeline for the design and construction of the facility, Mr. Correa noted some of the challenges encountered, the benefits of the facility and the number of traffic incidents, work zones, and weather events monitored and managed by the center during calendar year 2020.

City of Richmond Transportation Survey

Kelli Rowan of the City of Richmond Office of Equitable Transit and Mobility provided an overview of "Path to Equity", a policy guide for the Richmond Connects equitable mobility and accessibility plan. Ms. Rowan noted that

efforts to engage the community in the planning process had included pop-up events and an on-going survey. To encourage participation, the City has arranged for a food truck to be present at upcoming survey events, and individuals completing the survey are given vouchers for free food.

Next CTAC Meeting

The next CTAC meeting is scheduled for Thursday, September 16, 2021.

CRRSAA HIGHWAY INFRASTRUCTURE PROGRAM FUNDS

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: Review the proposed allocation strategy and provide a recommendation to the RRTPO Policy Board.

BACKGROUND: In December 2020, the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) of 2021 was enacted. In this legislation, Congress appropriated nearly \$10 billion in supplemental funding to FHWA for the Highway Infrastructure Program (HIP). The majority of this funding (\$9.8 billion) was apportioned to the states using the same formula as the Surface Transportation Block Grant (STBG) program which includes specific suballocations for urbanized areas with more than 200,000 people. For more information on the program, please see the FHWA implementation memorandum.

In total, the RRTPO share of the funding is \$7,642,406. This funding is split between two programs: HIP > 200k - \$1,166,204 and HIP-CRRSAA > 200k - \$6,476,202. Both funds are eligible to be used for anything that would be eligible for the STBG (formerly RSTP) program. In addition, the HIP-CRRSAA funds can also be used for preventative maintenance, routine maintenance, operations, personnel, debt service, availability payments, and other lost revenues (see the implementation memorandum linked above for details).

As with STBG funds, no local match is required for either program. The CTB provides the required 20% match for the HIP > 200k funds and the HIP-CRRSAA program allows for 100% federal funding and requires no match. These funds must be allocated, included in the TIP/STIP, and obligated before September 30, 2024, or they will lapse.

At the July meeting, TAC directed staff to develop an allocations plan which uses HIP funds on existing STBG and congestion mitigation and air quality (CMAQ) projects only. Staff has coordinated with VDOT to prepare a recommended strategy for allocating this funding.

<u>PROPOSED ALLOCATIONS:</u> In developing the recommended strategy, staff reviewed all active projects with a new phase starting in FY23. After a review of the budgets, schedules, and delays in implementation, UPC 113846 (Early Settlers Rd Sidewalk: Robious Rd to Hospital/Park – Chesterfield) and UPC 112042 (Route 1 Improvements: Ashcake Rd to Arbor Oak Dr – Ashland) were identified as viable recipients.

VDOT also reviewed active projects and suggested replacing STBG funds on UPC 13551 for construction which is starting this fall. This project is scheduled for completion in FY23 and replacing STBG allocations provides a better match between funding years and project schedule.

Finally, UPC 118153 (Brook Rd & Hilliard Rd Trail – Henrico) was reviewed to advance funding. This spring, the RRTPO approved a transfer of previous CMAQ funding to advance preliminary engineering (PE) on the project. Funding for right-of-way (RW) and construction (CN) need to be advanced with the next allocation plan. Rather than significantly reworking the CMAQ allocations plan, staff worked with VDOT to develop an allocation which covers RW and the balance of CN.

The table below summarizes the projects proposed to receive HIP funding and the STBG or CMAQ funding which will be returned to the balance entry.

For STBG, the HIP funds will offset existing STBG allocations for projects which are advancing on schedule and will be able to meet the obligation deadline. In total, the proposed use of HIP funds will free up \$2,427,251 in FY23 and \$2,503,258 in FY24 STBG funding which will be reallocated to new or existing STBG projects in the next funding cycle which will begin in October.

For CMAQ, the balance to complete selected projects required after FY27 will be reduced by \$2,711,897, or 27%. Funding for the Brook Rd & Hilliard Rd segment of the Fall Line will be fully advanced (a process started with approval of the surplus CMAQ transfer this spring) and the project will be able to start this fall rather than FY24 as originally allocated in 2020.

TRANSPORTATION ALTERNATIVES (TA) SET-ASIDE

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: Review the list of candidate projects and provide a recommendation to the policy board regarding endorsement of the applications.

BACKGROUND: The Transportation Alternatives (TA) Set-Aside program provides capital grant assistance for projects defined as "transportation alternatives" in federal code. The RRTPO TA allocations are directed towards on- and off-road pedestrian and bicycle facilities, infrastructure projects for improving bike and pedestrian access to public transportation, trails that serve a transportation purpose, and Safe Routes to School projects.

The TA application process is administered by VDOT through the Smart Portal. The deadline for preapplications was July 1, 2021. For the final application, each project within the RRTPO study area must include a resolution of endorsement from the RRTPO. For more information on the application process and requirements, see the VDOT Local Assistance Division web page.

To ensure the resolution of endorsement is approved before the October 1 application deadline, at the July TAC meeting RRTPO staff requested that all project sponsors submit the proposed project information by July 23, 2021, via email. At minimum the summary was to include the project name, a brief description, the total cost, and the requested TA funding.

PROJECTS SUBMITTED: Projects were submitted by Chesterfield, Hanover, and Henrico counties for endorsement. The table below includes a name and description of each project.

Chesterfield	Courthouse Road Shared-Use Path (Rte 10 to Fallow Dr)	This project will continue the effort to provide a pedestrian and bike facility along Courthouse Road as recommended in the County's Bikeways and Trail Plan. Ultimately this facility will connect to Pocahontas State Park.
Chesterfield	Fall Line (Shop St. to Chester Linear Park)	This project will construct a portion of the Fall Line Trail consistent with recommendations in the VDOT Ashland to Petersburg Trail study and will include a pedestrian crossing at the intersection with Route 10.

Chesterfield	Route 360 at Courthouse Rd	This project will install pedestrian accommodations at the intersection of Route 360 and Courthouse Road.

Chesterfield	Commonwealth Center Trail (Brad McNeer Pkwy to Craig Rath Blvd)	This project involves construction of a bike and pedestrian trail, which will run parallel to Swift Creek, from and along Brad McNeer Pkwy. to Craig Rath Blvd. The project also includes construction of a trailhead.

Trail will connect to Phase 1 with an at grade crossing of Dumbarton Road. A spur trail, approximately 250-ft in length, will connect to the Brook Run Drive (Overlook at Brook Run apartment community).

Henrico	Lakeside Community Trail - Phase 3	This is a segment of the regionally significant Fall Line Trail. The project consists of approximately 0.80 miles of 12-ft wide paved multi-use trail, termini points are Lakeside Recreation Area and Hilliard Road. STBG/CMAQ VDOT COORDINATION

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: No action requested at this time.

BACKGROUND: Selecting and prioritizing projects for funding is one of the primary roles of the RRTPO in developing the regional transportation system. Projects selected by the TPO to receive funding are included in the Six-Year Improvement Program (SYIP) for adoption by the Commonwealth Transportation Board (CTB). This process usually takes place from October to April of each fiscal year.

In June of 2021, the RRTPO Policy Board adopted new guidelines for project selection and allocation of Surface Transportation Block Grant (STBG) and Congestion Mitigation and Air Quality (CMAQ) funds. The newly adopted guidelines can be reviewed on the PlanRVA website.

A new requirement included in the guidelines is sponsor coordination with VDOT prior to submission of any application which will lead to construction. In the past, RRTPO staff has sent projects to VDOT for review which left little time to coordinated changes with project sponsors. The new approach allows project sponsors to work directly with VDOT to review the project estimate and schedule, allowing for more efficient and timely review. Coordination with VDOT can happen at any time, but the primary window for coordination will be July to October each year. This is the period when VDOT will have the most resources available to work on STBG/CMAQ projects.

To ensure adequate time for review, requests for coordination must be submitted to RRTPO staff via email no later September 29, 2021. RRTPO staff will review the projects for eligibility and email the sponsor and VDOT to initiate the review process. Project sponsors are encouraged to submit projects for coordination as early as possible.

VDOT Coordination Guidelines

Purpose

The Richmond Regional Transportation Planning Organization (RRTPO) coordinates closely with VDOT in the review of Regional Surface Transportation Block Grant (RSTBG) and Congestion Mitigation and Air Quality (CMAQ) project applications. VDOT has provided project cost estimate and schedule validation for several years during the project review process. This validation is used to develop funding plans for VDOT administered projects and to understand potential risks for projects that are intended to be locally administered.

To enhance coordination between project sponsors and VDOT, the Regional Project Selection and Allocation Framework requires applicants to coordinate review of the estimate and schedule for projects leading to construction with VDOT directly prior to submitting an application. This document lays out the options, process, and schedule for this coordination.

Coordination Options

VDOT offers several coordination options to assist in project development. The several options are detailed below.

- 1. Project Validation This option is required for all projects leading to construction. VDOT will review the project details and prepare a recommended cost estimate and schedule for the RRTPO. This VDOT validation must be submitted with all applications for RSTBG or CMAQ funding if the project will lead to construction. For projects that are to be VDOT administered, the funding application must match the VDOT schedule and cost estimate. For projects that are intended to be locally administered, the funding application is not required to match the VDOT schedule and cost estimate.
- 2. **Concept Development/Refinement** This option is available to applicants that have a concept which is not yet detailed enough for an application such as an improvement included in a comprehensive plan. VDOT will help the sponsor to refine the project scope and develop project sketches, estimates, and schedules as needed to prepare for the application.
- 3. Studies This option covers a range of potential coordination options including operational studies, safety studies, STARS studies, and AMP studies. These options can provide more information to applicants who have identified issues but have not yet identified solutions or who have project concepts that need additional study.

Process

The process for coordinating a project application is outlined below:

- 1. **Eligibility Screening** The project sponsor must submit an intent to apply to the RRTPO designated staff. RRTPO staff will verify sponsor, location, and project type eligibility. RRTPO will inform sponsor and VDOT of eligibility.
- 2. **Outreach to VDOT** Once the project has been deemed eligible, the sponsor can begin coordination with VDOT Richmond District. Coordination begins by submitting an intent to coordinate to the VDOT Planning point of contact.
- 3. **Coordination** VDOT planning will serve as coordinator between VDOT and the sponsor.

Schedule

VDOT is responsible for validating projects for a variety of funding programs. To ensure adequate time for project review, the primary coordination window will be from **June until three weeks before the application deadline** each year. Coordination is not limited to this time, but this is the time when VDOT staff will be most available to work on RSTBG and CMAQ applications.

Project validation must be requested at least three (3) weeks before the application deadline. For concept development and refinement, the coordination period is expected to be longer and must be requested at least six (6) weeks prior to the application deadline. More complex studies such as STARS, AMP, corridor, and small/special area plans must be requested at least twelve (12) months prior to the planned application deadline.
