Current Work Efforts Update – Item 5.a.

ConnectRVA 2045 Long-Range Transportation Plan

Staff initiated the screening and development of the regionally significant transportation projects within the RRTPO's Metropolitan Planning Area (MPA) Boundary based on the local and regional Issue Inventory spreadsheet as approved by the LRTP-Advisory Committee (AC) in their May 28 meeting. Staff developed the projects for issues which have a project solution based on completed or ongoing studies and sent the first cut list to the LRTP Advisory Committee (AC) members for their review. Staff will work with the Project Champions to develop the projects. Once the list of projects is completed and vetted by the AC it will be posted online for a two-week formal public review period. After the completion of public review period, it will come back to the AC for approval. Based on the timeline of the schedule for approval, the list of transportation projects is anticipated to be completed by November-December timeframe.

The Regional Goals and Priorities Survey was closed on August 15. The survey had around 7000 views and 501 completed responses. Staff presented the survey result to the AC on their August 28 Meeting. A companion <u>survey</u> went live around mid-August asking participants to share their Vision and Goals for ConnectRVA 2045. This survey will be shared widely to encourage participation.

<u>Greater RVA Transit Vision Plan: Near-Term Strategic Technical Analysis</u>

Five corridors or corridor segments have been identified for further analysis of service alternatives with varying capital and operating costs to lay the groundwork for determining a return on investment. The GRTC board was briefed on the cost analysis at their June 16th meeting. Technical Memo 2 has been reviewed by the steering committee, and the CTAC was briefed on July 16th. The TAC reviewed the technical analysis and agreed to refer the plan by resolution of approval to the TPO Policy Board for review and consideration for adoption. A story map that provides an overview of the process, recommendations and implementation guidance is also on the TPO Policy Board agenda for the September meeting.

Ashland Trolley Line Trail Study

The Ashland Trolley Line Trail advisory group is working in concert with the VDOT Ashland to Petersburg Trail Study. The localities along the corridor continue to identify segments of independent utility along the conceptual 14-mile route from Ashland to the City of Richmond. Several of these segments are the subject of funding applications either through the Transportation Alternatives (TA) program or SMART Scale. Staff continues to work with the National Park Service, Rivers, Trails, and Conservation Assistance program to discuss the scope of work for the upcoming FY21. Additional design assistance is being planned with the NPS help to engage the Virginia Chapter of the American Society of Landscape Architects and Virginia Tech through studio projects in the Fall semester. These efforts have led to the ongoing development of two story maps for the project; one on the history of the trolley line and a second is a design sketchbook.

Regional Bicycle and Pedestrian Plan Update

The <u>story map</u> of existing infrastructure, bike/ped features and statistics on bike/ped injuries and fatalities in the region has been completed and continues to be updated and refined. Staff has scheduled a fourth steering committee meeting for Sept. 15 to further review local priorities, future plans, and regional priority corridors as a foundation for depicting a regional network supported by clear goals, objectives and measures of performance that define regional impact and establish a strategy for implementation. Staff is holding smaller meetings between localities in preparation of the September 15 steering committee meeting.

Ashland Complete Streets Pilot Project

Complete streets guidelines, or a "tool-box" of resources, depicted through graphic and photographic examples are being prepared to serve as implementation support for the regional bike/ped plan. These images are intended to show specific locations where good standards have been implemented and where infrastructure improvements could incorporate complete streets elements for better solutions throughout the region. The illustrated <u>story map</u> is on the TAC agenda for review and input.

Active Transportation Work Group (ATWG)

Staff scheduled the next meeting of the ATWG for Sept. 8. Staff continues to work with Henrico County's Active Transportation Work Group, which is designed to advise the planning for a bicycle and pedestrian chapter of the county comprehensive plan.

Vision Zero Work Group

The second meeting for the newly created Vision Zero Work Group was held August 13, 2020 as a virtual meeting. Following the direction established at the June kickoff meeting, the group discussed adoption of a Vision and Mission statement and formation of local jurisdiction commissions with emphasis placed on training/resources, safety messaging, and analysis of serious crash outcomes. The comfort level was not sufficient among the group to take action on adopting vision and mission statements at the time, so it will be placed back on the agenda for further discussion at a future meeting.

American Planning Association-Virginia Chapter Annual Conference

Themed "We'll Get You Moving" representing the focus on multi-modal transportation, the in-person, <u>annual APA Virginia Chapter conference</u> previously scheduled in Richmond for will now be a virtual format during the week of October 12. (The Richmond conference will be rescheduled for 2022.) Production of prerecorded sessions and format is now being planned by the conference planning committee and log-in registration information will be posted soon.

SMART SCALE Round 4

Staff worked with local government staff and VDOT to complete full applications in time for the application deadline of August 17, 2020. The RRTPO Policy Board took action on July 2, 2020 to approve the final list of ten regionally significant projects. The CTB is scheduled to release project prioritization and base allocation scenarios in January of 2021.

Prioritization of VTrans Mid-Term Needs

Background: Earlier this year, the Commonwealth Transportation Board (CTB) accepted the 2019 VTrans Mid-term Needs and directed the Office of Intermodal Planning and Investment (OIPI) to prioritize the identified Needs. Based on direction from the CTB, the prioritized 2019 Mid-term Needs may form the basis for VDOT and DRPT's planning and project development efforts as well as policies related to transportation programs and activities.

OIPI will be hosting a series of virtual workshops and online engagement to share the initial prioritization of the 2019 VTrans Mid-term Needs to actively collaborate with local and regional transportation partners to improve our methodology, similar to that done during the 2019 VTrans Regional Workshops.

- 1. Utilize local and regional knowledge to ensure that methods are accurate and appropriately capture the most pressing transportation needs in each Construction District and the Commonwealth.
- 2. Gather feedback from local and regional stakeholders on thresholds for prioritization of the identified VTrans Mid-term Needs.
- 3. Convey the trade-offs that the Commonwealth must consider while investing resources in identifying solutions for VTrans Mid-term Needs.

FY22 - FY27 RSTBG/CMAQ SCHEDULE

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: No action is requested; this is an update on the schedule for the FY22 – FY27 RSTBG and CMAQ application cycle.

BACKGROUND: The FY21 – FY26 project selection and allocation process was significantly delayed due to COVID-19 and the subsequent suspension of SYIP development. Given the delays and after discussion with VDOT, the application cycle will be pushed back to October for this next round and shortened to 1 month. The rest of the schedule is expected to follow previous practice, with new allocations finalized by April.

Project sponsors will be required to submit applications through the electronic form this year. Building on the changes made last year, all application types are consolidated into a single form and will be accessed through the same link. Submitting the applications electronically facilitates data management and streamlines the application review process.

Staff is working to prepare guidance regarding suggested supplemental materials for new project applications. This guide is intended to offer more insight for sponsors when preparing the application to ensure submissions provide all necessary information for scoring. This guidance will be distributed along with the application link.

The application window for the FY22 – FY27 RSTBG/CMAQ funding will open on October 1, 2020, and close on October 30, 2020. All applications and supplemental materials are due by 4:30 p.m. on Friday, October 30, 2020. Late submittals will not be accepted.

The schedule for this round of applications is attached for review. The application link will be sent to TAC members and eligible applicants via email on Monday, September 28, 2020.

SMART SCALE ROUND 4 LOCAL PROJECT ENDORSEMENTS

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: Review of locality and transit agency Smart Scale applications and recommendation to policy board regarding support for projects not consistent with the Long-Range Transportation Plan (LRTP) or located on Corridors of Statewide Significance.

BACKGROUND: The application window for Round 4 of Smart Scale closed on August 17, 2020. All local and regional applications have been submitted. To support local and regional planning efforts and consistency with the Constrained Long-Range Plan (CLRP), a resolution of support from the MPO is needed for all projects within the MPO study area that are not included in or consistent with the adopted CLRP. This requirement applies to projects submitted by localities and transit agencies.

In addition to the consistency requirements, an MPO resolution of support is also required for all locality sponsored projects on a CoSS. This requirement does not apply to transit agencies. Table 2.2 from the Smart Scale Technical Guide which summaries the requirements for MPO support is reproduced below.

Due to the disruption in meetings caused by the COVID-19 pandemic, the required resolutions of support were not required for submission of applications on August 17, 2020. The deadline for submission of MPO resolutions of support is October 30, 2020.

Staff requested a summary of local projects from all TAC members by August 21, 2020. Attached to this report is a summary of the member organization submissions. Each project was reviewed to determine (1) if it is specifically listed in the constrained long-range plan, or (2) if it is consistent with the long-range plan but not specifically listed. Each project submitted by a locality was also screened for location on a CoSS.

The attached project summary table identifies the rationale for including a specific project on the resolution of support. Staff requests TAC members review the summary sheet and draft resolution. For projects identified as CoSS projects, staff requests TAC members confirm whether the project application includes a CoSS need. Any changes to the list should be noted before TAC makes a recommendation.

Complete Streets Guidance/Toolbox

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: No action is requested. Staff provides this progress update and requests TAC review and input on the use of the Complete Streets toolbox to help guide implementation of the Regional Bicycle and Pedestrian Plan (BP Plan) as one means of implementing a multi-modal network that is safer for all users and economically viable for the Richmond region.

BACKGROUND: Initiated by the Community Transportation Advisory Committee (CTAC) in 2017, the Complete Streets work effort has evolved from consideration of possible regional policy guidance through research of best practices to their application in the Town of Ashland. Smart Growth America (SGA) and Michael Baker International conducted a series of workshops to actively engage partners and the public during the summer-fall 2019.

This Ashland pilot project provided the foundation for the creation of a tool-box in the form of a readily updatable Story Map of best practices examples and specifications for the region's localities to draw from in working with VDOT, developers, and their own staff to implement a roadway network that is more complete, safer for all users, contributes to stronger economies. This will be regularly updated.

TAC REQUESTED ACTION: No action is requested. Staff provides this progress update on the Complete Streets Toolbox, for TAC review and comment. Staff will continue to provide regular updates throughout the program year in conjunction with the development of the updated BP Plan.
