Current Work Efforts Update – Item A.5.a.

ConnectRVA 2045 Long-Range Transportation Plan

Staff developed Vision, Guiding Principles, Goals and Objectives for the plan based on the public surveys and LRTP-Advisory Committee (AC) input. This will be presented to the Policy Board in December. Staff has also been working with AC to develop regionally significant transportation projects within the RRTPO's Metropolitan Planning Area (MPA) Boundary. The product will be a streamlined list of transportation projects which will be called the Universe of Projects. Staff anticipate completing the list by the end of the year.

Ashland Trolley Line Trail Study

The Ashland Trolley Line Trail advisory group is working on the northernmost section of the recently named Fall Line trail (formerly Ashland to Petersburg). The localities along the corridor continue to identify segments of independent utility along the conceptual 14-mile route from Ashland to the City of Richmond. Several of these segments are the subject of funding applications either through the Transportation Alternatives (TA) program or SMART SCALE. The third program year of technical assistance through the National Park Service (NPS), Rivers, Trails, and Conservation Assistance Program will focus on obtaining design assistance and exploring trail management alternatives. Two story maps for the project have been developed to illustrate the importance and design potential, including history of the trolley line and a design sketchbook.

Regional Bicycle and Pedestrian Plan Update

The purpose of this project is to update the 2004 regional plan as a central component of the ConnectRVA2045 long range transportation plan. A <u>story map</u> of existing infrastructure, bike/ped features and statistics on bike/ped injuries and fatalities in the region continues to be updated and refined. Staff held a fifth steering committee meeting on October 29 to further review potential projects that create a regional network, and finalize the vision, goals, objectives. Possible measures of performance were introduced that will be the subject of the next steering committee meeting in early December.

Ashland Complete Streets Pilot Project

Complete streets guidelines, or a "tool-box" of resources, depicted through graphic and photographic examples are being prepared to serve as implementation support for the regional bike/ped plan. These images are intended to show specific locations where good standards have been implemented and where infrastructure improvements could incorporate complete streets elements for better solutions throughout the region. The illustrated story map is available for review and continues to be updated.

Active Transportation Work Group (ATWG)

Staff is working on scheduling the next meeting of the ATWG for mid-December. Staff participated in the November meeting for the Henrico County Active Transportation Work Group, which is designed to advise the planning for a bicycle and pedestrian

chapter of the county comprehensive plan. Henrico staff shared their document review for their planning, gave updates on bicycle and pedestrian projects in the county and on the work being done for the county's comprehensive plan.

Public Transportation Work Group

This work group met on <u>November 2, 2020</u> and is supporting GRTC in the development of the scope of work and the project tasks required to complete the development of a Regional Public Transportation Plan. GRTC has entered into negotiations with a consultant and the plan development process is expected to begin soon.

- Participated in on-going meetings of the Long-Range Transportation Plan Public Engagement Committee. Among the topics discussed were documenting the online survey responses, finalizing the language concerning the plan's goals, objectives and performance measures, and updates to the LRTP website. Followed up by reviewing and providing comments on the plan's goals, objectives and performance measures
- Participated in the LRTP Advisory Committee (AC) meeting on October 22. The meeting included a staff presentations and interactive sessions on Task 2: Development of Vision, Goals and Objectives., Task 3: Development of the Universe of Projects and Task 4: Project Scoring and evaluation.
- The Vision, Goals, and Strategies survey was closed on October 11, with 949 responses. Staff synthesized the responses and presented them to the LRTP-AC on their October 22 meeting. With public and AC input, staff is working to develop Vision, Goals and Objectives for the plan.

• Staff continued to work with East Coast Greenway Alliance (ECG) staff on preparations for new designations for the ECG along the new protected bike lanes in North Richmond. A virtual meeting was held with staff from the City of Richmond to discuss potential rerouting of the trail in the City as well as removing the designations of portions of the trail due to realignment or changed expectations for the alignment of the ECG. Meetings were scheduled for Henrico and Hanover counties as well.

Richmond Regional Bicycle and Pedestrian Plan

- Staff held a steering committee meeting on October 29 which included continued discussion of the vision statement, and related goals and objectives for the regional bicycle and pedestrian plan. RRTPO Boundary Adjustment

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: RRTPO approval to endorse and begin the process of updating its boundary to match the boundary of the Richmond Regional Planning District Commission (PlanRVA) and the Central Virginia Transportation Authority (CVTA).

<u>BACKGROUND</u>: With the advent of the Central Virginia Transportation Authority in 2020, Mr. David Williams, Board of Supervisors (Powhatan), requested that RRTPO staff consider the opportunity to expand the RRTPO boundary to match both the PlanRVA boundary and CVTA boundary – Planning District 15. Chet Parsons held subsequent conversations with Dan Lysy, former Director of Transportation at PlanRVA, and Richard Duran, liaison with FHWA, to gather feedback on the prospect.

In these conversations, there is an opportunity to assess the implications of a boundary change and determine if the positives outweigh the negatives for such a change at this time.

The information shared below was discussed by the RRTPO Policy Board at its October meeting and initiated the request for TAC to consider the action and make a recommendation at the December RRTPO Policy Board meeting. Staff presented the following factors for consideration to the policy board:

- 1. The Metropolitan Planning Area (MPA) boundary can be expanded from time to time to adapt to the growth of the region.
- 2. The MPA is required to be evaluated following every decennial Census. The next time period for evaluation of the Richmond MPA is roughly 2022.
- 3. Expansion of the MPA to include all of Charles City, Goochland, New Kent, and Powhatan Counties would present the following considerations:
 - a) The TPO boundary would match the boundary of PlanRVA and the CVTA and could increase public awareness and understanding of the TPO as well as general uniformity region-wide.
 - b) RSTP/CMAQ funding may be available for projects in wider geographic areas of the four current partially-included jurisdictions.
 - c) With a change to the MPA, rural transportation planning assistance from VDOT may become unavailable to assist in planning studies for the four rural jurisdictions (roughly \$58,000 annually). This loss would be realized by PlanRVA and would diminish staff budget for assistance to member jurisdictions.

Since the October TAC meeting, staff held individual discussions with each of the four jurisdictions that hold both rural and urban area in the current MPO Study Area. This consideration does NOT include southern Chesterfield County, which shares geographic area between the Richmond and Petersburg urbanized areas. **Each of the jurisdictions of Powhatan, Goochland, New Kent, and Charles City Counties supports the expansion of the MPO Study area to include the full geographic area of the counties.**

TAC considered all of the information presented above during its November meeting and recommends that the policy board proceeds with the process of changing its Metropolitan Planning Area as proposed, by a vote of 7Y, 3N, 2A.

STAFF RECOMMENDATION: Staff concurs with the RRTPO Technical Advisory Committee recommendation supporting the expansion of the RRTPO Metropolitan Planning Area to include the entirety of Powhatan, Goochland, New Kent, and Charles City Counties.

A RESOLUTION REQUESTING EXPANSION OF THE RICHMOND REGIONAL TRANSPORTATION PLANNING ORGANIZATION (RRTPO) BOUNDARY TO ENCOMPASS ALL OF POWHATAN COUNTY

WHEREAS, the boundaries of the Richmond Regional Transportation Planning Organization (RRTPO), Richmond Regional Planning District Commission (PlanRVA), and Central Virginia Transportation Authority (CVTA) currently do not align;

WHEREAS, all of Powhatan County lies within the boundaries of PlanRVA and the CVTA, but is only partially located with the RRTPO boundary;

WHEREAS, a portion of the Courthouse Village Special Area Plan (one of three growth areas in Powhatan County designated by the 2019 Long-Range Comprehensive Plan) is located outside of the RRTPO boundary, limiting access to state and federal transportation funds that could support transportation improvements necessary to accommodate economic development within an area targeted for future growth;

WHEREAS, a portion (more than nine miles) of U.S. Route 60 (Anderson Highway), a major highway that supports economic development throughout Central Virginia, is located outside of the RRTPO boundary, limiting access to state and federal transportation funds that could support safety and capacity improvements that benefit the entire region;

WHEREAS, Powhatan State Park, a regional destination that attracts more than 100,000 visitors annually, is located outside of the RRTPO boundary; and

WHEREAS, aligning the boundaries of the RRTPO, PlanRVA, and CVTA will improve public understanding of regional planning, transportation planning, and transportation funding, as the service area of all regional transportation planning entities would align, encompassing Powhatan County in its entirety.

NOW, THEREFORE, BE IT RESOLVED, that the Powhatan County Board of Supervisors supports expansion of the RRTPO boundary to encompass all of Powhatan County, aligning with the boundary of PlanRVA and the CVTA.

ConnectRVA 2045 Update – Vision, Goals & Objectives

Richmond Regional Transportation Planning Organization

REQUESTED ACTION: The RRTPO Policy Board is requested to review the draft Vision, Guiding Principles, Goals and Objectives of the ConnectRVA 2045 plan and to open a 15-day public review and comment period.

BACKGROUND: ConnectRVA 2045 is the name of the new long-range transportation plan that is currently under development. The long-range transportation plan is the document which sets the vision for the next 20 years of transportation improvements in the region and includes a financially constrained list of projects which are expected to be built over that time period. The Long-Range Transportation Plan – Advisory Committee (LRTP-AC) spearheads the development of the LRTP with autonomy to make decisions guiding the process and outcomes. The 2045 LRTP is due by September 2021.

RRTPO conducted a series of public surveys from June through October. These surveys were targeted for public input in defining what vision, goals, and strategies should be for the plan. The surveys were successful with around 1500 completed surveys. Based on the results of these surveys, staff synthesized the responses and presented them to the LRTP-Advisory Committee for their input. With public and LRTP-AC input, staff has developed the draft Vision, Guiding Principles, Goals and Objectives for the plan.

REQUESTED ACTION: This is an information item; no action is requested.

BACKGROUND:

Bridges, culverts, and tunnels (called structures collectively) are critical building blocks of an efficient transportation system. Bridge location, design, and structural health are a key element in planning and maintaining an effective transportation network. Bridge dependability is especially important in the Richmond region due to the relatively high number of bridges in a region with numerous interstate freeways and state highways, the crossroads of three major railroad systems, and multiple major rivers and the creeks and streams that feed them. Concerned about the number of aging bridges in the region and the apparent lack of funding for maintaining or replacing them, RRTPO began tracking the condition and funding of the region's bridges since 2014.

The 2020 Richmond Regional Structural Inventory Assessment Report provides inventory of the structures in the Richmond region (i.e., Planning District 15) and includes VDOT system and non-VDOT system roads (i.e., Richmond and Ashland urban system, Henrico secondary system, RMTA, and private bridges and culverts). and identify those in poor condition (i.e., structurally deficient, weight posted, etc.). The report utilizes snapshot data captured from the online dashboard maintained by the Virginia Department of Transportation (VDOT) as of January 15, 2020.

The report also documents the Commonwealth's State of Good Repair (SGR) Prioritization Process Methodology for replacement and rehabilitation of structurally deficient state and locally owned bridges as adopted by the Commonwealth Transportation Board (CTB) and include a latest prioritized list for all VDOT-owned and locality-owned bridges in the Richmond region.

The list of structures in the region which are in the poor conditions will be fed into **ConnectRVA 2045** plan as bridge replacement/rehabilitation needs within the SGR funding pot.

Report

The following is a brief report on major discussion items from the November 19, 2020 CTAC meeting.

Update on Connected and Autonomous Vehicles

Virginia Transportation Research Council Senior Research Scientist Noah Goodall provided an overview of <u>automated shuttle deployment test programs</u> in Virginia. He noted that VDOT was supporting a service at Joint Base Myer-Henderson Hall as well as the Fairfax County "Relay" automated shuttle program. Relay is an autonomous shuttle operating between the Dunn Loring Metro station and the Mosaic District. The pilot project is a partnership between Fairfax County, EDENS (Mosaic), VDOT, Virginia Tech Transportation Institute and George Mason University. The fully accessible shuttle is viewed as a test of a first/last mile travel option, connecting people from transit centers to employment and activity centers and residential communities. The purposes of the test include: (1) To learn more about how this technology can be safely and effectively used in the future; (2) to offer additional mobility solutions; (3) to help familiarize people with new transportation technologies; and (4) to encourage environmentally friendly transportation solutions. The pilot involves some 10 different agencies and organizations as well as federal, state and local regulatory agencies.

ConnectRVA 2045 Status Update

Sulabh Aryal, Planning Manager, provided an update on the ongoing tasks associated with the development of the regional transportation plan, <u>ConnectRVA 2045</u>. He reviewed the outcomes of the screening and selection of the regionally significant transportation projects and the development process for the plan's vision, goals and strategies. Mr. Aryal noted that the surveys and public input had helped with the development of five guiding principles: (1) safe, well-maintained and interconnected transportation; (2)

choice among all travel options; (3) prioritize completion of regional bicycle and pedestrian networks; (4) equity and inclusion; and (5) alignment of transportation investment.

Complete Streets Guidance/Toolbox

Sara Rozmus, Planner, presented the background of the <u>Complete Streets</u> Guidance/Toolbox. The work effort has evolved from consideration of possible regional policy guidance through research of best practices to application in the Town of Ashland. The Ashland pilot project provided a foundation for the creation of a toolbox in the form of best practice examples and specifications that can help implement a roadway network that is more complete and safer for all users. The toolkit will be used to help guide implementation of the Regional Bicycle and Pedestrian Plan.

Greater RVA Transit Vision Plan-Near Term Strategic Technical Analysis

Barbara Jacocks, Principal Planner, summarized the background and recommendations of the <u>Greater RVA Transit Vision Plan</u>. The purpose of the plan was to analyze and recommend selected high-frequency routes for successful implementation in the near-term. Twelve corridors were initially selected in the first screening phase. In the second phase of analysis, access to community facilities, walkability, pedestrian networks, roadway suitability and ridership potential were all considered, and five corridors were recommended to move forward with more detailed capital and operating cost estimate development.

I-95/RMT/Commerce Corridor Access Study

Chet Parsons, Director of Transportation, presented the findings and recommendations of the <u>I-95/Richmond Marine Terminal/Commerce Road Corridor Access Study</u>. The study was commissioned by VDOT in collaboration with PlanRVA and the Port of Virginia to identify and develop solutions to access and safety challenges in the area surrounding the I-95/Bells Road interchange and Commerce Road. In addition to documenting transportation safety and operation challenges, the plan has identified short- and long-term infrastructure improvements that will allow the corridor to reach its full economic potential.

The next CTAC meeting is scheduled for Thursday, January 21, 2021.
