The Richmond Regional Transportation Planning Organization (RRTPO) Policy Board Chair, Patricia A. Paige, presided and called the April 1, 2021 RRTPO Executive Committee action meeting to order at 8:32 a.m.

#### 4. RRTPO Chairwoman's Report

Chair Paige expressed her appreciation for everyone joining the meeting and reported on road problems in New Kent County due to flooding and standing water. Drainage concerns can be reported to VDOT's Customer Service Center.

## 5. RRTPO Secretary's Report

Chet Parsons, RRTPO Secretary, reported on the following items:

a. Title VI Update

The RRTPO is required to comply with Title VI of the Civil Rights Act of 1964 (Title VI) to assure nondiscrimination in all its programs and activities. As a result of the Title VI compliance review, VDOT has found two deficiencies in the implementation of the MPO's responsibilities under the Title VI Program. The RRTPO needs to update and submit their Title VI Plan for review and approval with a due date of June 11th. Additionally, the RRTPO did not insert the Title VI/nondiscrimination paragraph from the U.S. Dot Standard Title VI Assurances into RFP that was supplied for the purposes of this review. A task order contract will be issued to PlanRVA's bench to assist the RRTPO with updating the Title VI Plan.

## b. Staffing Plan Discussion

An update on the staffing plan for the RRTPO was provided. A proposed organizational chart detailing current staffing needs was supplied and discussed by committee members. The budget is situated to absorb these changes in staffing and opportunities for review by the PlanRVA Commission as well as the RRTPO Policy Board will be provided prior to any staffing updates.
