#### **Opening Statement for Electronic Meetings**

In light of the 2020 COVID-19 virus and current guidance regarding physical distancing to reduce the potential for spread, meetings of the Richmond Regional Planning District Commissions have transitioned to a virtual format. Regional Public Bodies were granted authority to conduct meetings electronically, pursuant to the provisions of Virginia Code § 2.2-3708.2 and related legislation approved by the General Assembly of Virginia during the period of the Governor's State of Emergency Declaration for COVID-19.

While we do not know the exact duration of the current practice of electronic meetings, we will continue to function in this manner until such time as it is deemed appropriate to return to in-person meetings.

Staff provided notice of this meeting and the means by which we are virtually gathered to members of the public on September 21, 2020 through electronic posting on the PlanRVA website and email distribution of notice to members, alternates, and known interested parties, including the media.

All comments and questions submitted during the meeting will be reviewed following the meeting and to the extent practical, responses will be provided or posted on the PlanRVA website.

#### **CALL TO ORDER**

The Richmond Regional Transportation Planning Organization (RRTPO) Policy Board Chair, Patricia A. Paige, presided and called the September 3, 2020 RRTPO Executive Committee action meeting to order at 8:37 a.m.

Thornton, Henrico County, as FY21 Chair, and the CVTA FY21 Vice Chair is Mr. Kevin P. Carroll, Chesterfield County. The CVTA Finance Committee elected Mayor Levar M. Stoney, City of Richmond, as FY21 Chair and Mr. W. Canova Peterson IV, Hanover County, as FY21 Vice Chair. The CVTA Finance Committee is scheduled to meet on September 18<sup>th</sup> at the PlanRVA offices with an option of virtual attendance. After finalizing all appointees for the CVTA Technical Advisory Committee, the committee will be scheduled to meet for their first meeting at the earliest possible time.

#### 6. Eighth Annual Transportation Forum

Ms. Patricia Paige, RRTPO Chair, opened the floor for conversation on canceling or postponing the annual transportation forum in November 2020.

Following a brief discussion, on motion of W. Canova Peterson IV, seconded by John H. Hodges, the Richmond Regional Transportation Planning Organization (RRTPO) Executive Committee unanimously voted to approve the following resolution:

**RESOLVED**, that the Richmond Regional Transportation Planning Organization (RRTPO) Executive Committee recommends to the RRTPO Policy Board to cancel the Eighth Annual Transportation Forum in November 2020 and defer it to spring 2021 due to ongoing uncertainty regarding the COVID-19 pandemic (see Appendix A).
