Funding & Programming Activities*

- SMART SCALE Round 6 (FY26 FY31 SYIP)
 - o Pre-application opened on March 1, 2024, and will close on April 1, 2024.
 - o Full applications will open on June 1, 2024, and close on August 1, 2024.
 - All supporting documentation will be required by July 15, 2024.
- Transportation Alternatives Program (TAP)
 - FY 2025 2026 Application Cycle: Scorecards have been released to CTB District Members/TMAs for use in selections.
- Revenue Sharing Program
 - o Revenue Sharing selections will be presented in the Spring of 2024.
- Six-Year Improvement Program (SYIP) Development
 - Development of the FY 2025-2030 SYIP is underway.
 - A draft SYIP is anticipated to be presented to the CTB in April.
 - We anticipate holding spring meetings in each District in the April timeframe.
 - A final SYIP will be provided for CTB action at the June Board meeting.

- Fall Line
 - VDOT Design-Build Packages
 - DB#1 (Holly Hill Rd to Walder Ln; includes Chickahominy River crossing, UPC 121374)
 - Construction is anticipated to begin in Spring 2024.
 - DB#2 (Patton Park to W Hundred Rd/Chester Linear Park, UPC 121511)
 - Good progress is being made on the alignment at the southern terminus.
 - Advertisement date will be determined once the alignment is finalized and approved (anticipated to be in 2024).
- I-64 GAP Widening
 - Segment A MM 204.9 to MM 215.6 in New Kent County (UPC 122805)
 - Estimated completion of this section is Summer 2027
 - Segment B MM 215.6 to MM 224.3 in New Kent County (UPC 123831)
 - VDOT anticipates releasing the RFP in the Summer of 2024
 - Estimated completion of this section is Spring / Summer 2028
 - Segment C MM 224.3 to MM 233.3 in James City County/Hampton Roads District (UPC 123129 & 123832)
 - Reguest for Proposals (RFP) released in November 2023
 - Scheduled for CTB Award in April 2024
 - Estimated completion of this section is Fall 2027
