  - **Agenda Items related to the Richmond District and Richmond Regional TPO:**
  - Regulatory Reduction Program & Proposed Regulatory Amendments – Rules/Regulations for the Administration of Waysides and Rest Areas (24VAC30-50) and Rules/Regulations for the Administration of Parking Lots and Environs
    - Significant Amendments:
      - Reduce duplications.
      - New allowance for state government entities to request permission for activities at and uses and occupation of rest areas not otherwise prohibited by state or federal law such as parking lot events on weekends and mobile food vending.
      - Achieve administrative updates, add clarifying language, and bring the text in line with current practice.
  - Proposed Regulatory Amendments – Rules and Regulations Controlling Outdoor Advertising and Directional and Other Signs and Notices, 24VAC30-120
    - Significant Amendments:
      - Significant reorganization and streamlining of the regulation to make the text easier for regulated entities to read and understand
      - Nonconforming signs
        - ❖ The number of months a nonconforming sign can be blank will be revised from 18 months to 24 months to provide added flexibility to regulations
        - ❖ The number of days the sign owner has to display a message after receiving written notice will be revised from 120 days to 30 days in conformance with the timeline for corrective action set in § 33.2-1229

    - Statewide Pre-Application Insights
      - 109 pre-applications
      - 8 screen-out decisions
    - Statewide Full Application Insights
      - 89 full applications were submitted, of which Richmond District had 20 full applications and requested \$27.7M
      - 7 screen-out decisions
      - \$131.5M total requests for \$247.9M total estimated project costs
      - Two existing project requests valued at \$2M
    - FY 27/28 Available Allocations and Distributions – MPO Selection Responsibility
      - Richmond Regional TPO – \$4.7M
      - Tri-Cities Area MPO – \$0.6M

  - **Agenda/Action Items related to the Richmond District and Richmond Regional TPO:**
  - Action on Limited Access Control Changes (LACCs) for the I-64 and Route 623 (Ashland Road) Interchange Improvements Project 0064-037-805, P101, R201, C501 UPC# 123919
    - Issues: The area designated as limited access previously approved for I-64 needs to be modified to accommodate interchange improvements at Route 623. These changes require the approval of the CTB.
    - Recommendations: VDOT recommends that I-64 continue to be designated as limited access with the LACCs modified and/or established as shown on the attached exhibits. This action will modify the limited access line and right of way previously approved by the CTB on September 20, 1962.
    - Result: Motion carried, resolution approved, unanimously.
  - Action on FY2026-2031 Six-Year Improvement Program Transfers November 15, 2025, through December 12, 2025
    - Issue: Each year the CTB must adopt a SYIP in accordance with statutes and federal regulations. Throughout the year, it may become necessary to transfer funds between projects to have allocations available to continue and/or initiate projects and programs adopted in the Program. Within the Richmond District, we had two SYIP Allocation Transfers that required approval:
      - First SYIP Transfer:
        - ❖ Donor UPC/Description: 70700 – Statewide Highway Safety Balance Entry
        - ❖ Recipient UPC/Description: 117778 Signal MUTCD Compliance Upgrades – Districtwide
        - ❖ Fund Source: VA Safety HSIP – Federal and VA Safety HSIP – Soft match
        - ❖ Transfer Amount: \$227,041
        - ❖ Total Allocation: \$692,411
        - ❖ Total Estimate: \$692,411
        - ❖ Comments: Transfer of surplus funds recommended by District and Traffic Operations Division from the Statewide Highway Safety Balance Entry line item to fund an underway project.
      - Second SYIP Transfer:
        - ❖ Donor UPC/Description: 127921 - #SMART26 – I-95 at Rives Road Exit Roundabouts
        - ❖ Recipient UPC/Description: 118949 - Appomattox River Trail (ART) – Western Extension
        - ❖ Fund Source: CMAQ: Tri-Cities and CMAQ Match: Tri-Cities
        - ❖ Transfer Amount: \$341,627
        - ❖ Total Allocation: \$1,130,892
        - ❖ Total Estimate: \$1,167,941
        - ❖ Comments: Transfer of surplus funds recommended by District and MPO from a scheduled project to fund an underway project.

- Result: Transfers were approved, unanimously.
- Action on Addition of Projects to the Six-Year Improvement Program for Fiscal Years 2026-2031
  - Issue: Each year the CTB must adopt a SYIP and allocations in accordance with the statutory formula. There were two projects listed that will be added to the SYIP for FY26-31 within the Richmond District:
    - UPC Number: T31239
      - ❖ Project Description: Richmond Structure Recoating - #4
      - ❖ Total Cost: \$5,642,040
      - ❖ Total Allocation: \$5,642,040
      - ❖ Major Fund Source: Bridge Formula Program
    - UPC Number: T31240
      - ❖ Project Description: Richmond Structure Recoating - #5
      - ❖ Total Cost: \$5,373,540
      - ❖ Total Allocation: \$5,373,540
      - ❖ Major Fund Source: Bridge Formula Program
  - Recommendations: VDOT recommended the addition of the projects to the Program for FY 2026–2031.
  - Result: Motion carried, resolution approved, unanimously.
- Action on Location Approval for the Powhite Parkway Project
  - Issue: The Powhite Parkway Project Environmental Impact Statement (EIS) involves the consideration of the construction of a four-lane road from Woolridge Road to Hull Street Road, to include reconstruction of an existing two-lane road from Hull Street Road to the Westerleigh Parkway Extension, identified as “Alternative 1A” in the presentation to the CTB on December 9, 2025. Pursuant to Va. Code § 33.2 208, the CTB is required to locate and establish the routes to be followed by the highways comprising the systems of state highways.
  - Recommendations: VDOT recommended approval of the location of the Project as presented at the Location Public Hearing and as shown in Exhibit A.
  - Result: Motion carried, resolution approved, unanimously.
- Delegation of Authority to Correct Virginia Manual on Uniform Traffic Control Devices (MUTCD), Version 11.0
  - Issue: VDOT seeks approval from the CTB to delegate authority to make minor edits to the Virginia Manual on Uniform Traffic Control Devices, which includes the Work Area Protection Manual (Virginia MUTCD), version 11.0
  - Recommendations: VDOT recommended the Board authorize the Commissioner of Highways.
  - Result: Motion carried, resolution approved, unanimously.
- Action on Making Efficient and Responsible Investments in Transit Program Review
  - Issue: The Code of Virginia requires that the CTB evaluate DRPT's transit operating assistance methodology ("MERIT Operating Assistance") every three years. Any changes require consultation with DRPT, TSDAC, and interested stakeholders, and shall provide for a 45-day public comment period, before being considered for approval.
  - Recommendation: Considering the TSDAC's resolution seeking a delay, and considering the 10 months of work invested by DRPT staff, consultants, and stakeholders, DRPT recommends that the CTB resolve to take future action on the MERIT operating formula and capital prioritization process changes, no later than the May 2026 CTB Action Meeting.
  - Result: Motion carried, resolution approved, unanimously.
- Action on Transportation Partnership Opportunity Fund Allocation to the County of Chesterfield for the West Area Arterial Collector Project
  - Issue: The Governor has directed \$35.0 million from the Transportation Partnership Opportunity Fund (TPOF) to the CTB pursuant to § 33.2-1529.1 of the Code of Virginia for allocation to the County of Chesterfield for the West Area Arterial Collector Project. The direction of funds has been recommended by the Secretaries of Transportation and Commerce and Trade and CTB allocation of said funds to the County for the Project is sought.
  - Result: Motion carried to allocate the funds, unanimously.
- Action on Regulatory Reduction Program and Final Regulatory Amendments: Rules/Regulations for the Administration of Waysides and Rest Areas (24VAC30-50) and

### Rules/Regulations for the Administration of Parking Lots and Environs (24VAC30-100)

- **Issue:** VDOT is requesting approval from the CTB to move forward with the final stage amendments to consolidate and amend the Rules and Regulations for the Administration of Waysides and Rest Areas (24VAC30-50) and Rules and Regulations for the Administration of Parking Lots and Environs (24VAC30-100). VDOT received no public comments during the proposed stage public comment period, and as such, recommends no changes to the amendments as previously approved by the CTB.
- **Recommendations:** VDOT recommended the CTB authorize VDOT to file the final regulatory stage, including the proposed consolidation and amendments and associated Agency Background Document, for 24VAC30-50 and 24VAC30-100.
- **Result:** Motion carried, resolution approved, unanimously.
- Action on Next Gen Traffic Operations Data Service (Next Gen) Contract Award
  - **Issue:** VDOT solicited proposals from qualified firms to contract for a Next Gen Traffic Operations Data Service capable of providing high-fidelity, low-latency data to the Richmond District Traffic Operations Center to enable shorter incident response times, decrease congestion caused by incidents, increase safety on the corridor, and be able to communicate real-time data to the travelling public. CTB approval of this contract is required by Virginia Code § 33.2-209 as a contract for “construction, maintenance, and improvement of the highways comprising systems of state highways in excess of \$5 million.”
  - **Recommendations:** VDOT recommended that the CTB approve and authorize the Commissioner of Highways to execute the contract with Cavnue, LLC, to provide the Next Generation Traffic Operations Data Service.
  - **Result:** Motion carried, resolution approved, unanimously.
