SYIP Development

- Revised FY21 Budget will be presented to CTB in December 2020
- Official revenue estimate for FY22-FY27 available in December 2020
- FY2020-2025 SYIP will remain in effect through June 30, 2021
 - Includes updates approved by the CTB for recently approved funding programs such as Revenue Sharing, Transportation Alternatives (TAP), RSTBG, and CMAQ
- Development of the FY22-27 SYIP will begin in 2021

Interstate Studies: I-95, I-85, I-64, & I-295 [No Change from Last Update]

Interstate 64/664 Corridor Improvement Plan – Round Two

You are invited to view an enhanced project website to learn about the Interstate 64/664 Corridor Study and provide input on potential targeted safety and congestion solutions

The Commonwealth Transportation Board, with support from the Office of Intermodal Planning and Investment, the Virginia Department of Transportation and the Department of Rail and Public Transportation, is developing an I-64/664 Corridor Improvement Plan. The plan will be developed as part of a data-driven study to (i) identify key problem areas along the corridor, and (ii) identify potential solutions and areas for additional review and study.

You are invited to provide additional input on the I-64/664 Corridor Improvement Plan online during the second in a series of online feedback opportunities for this plan. The purpose of this second round is to gather public input on safety and congestion improvement recommendations on the I-64 and I-664 corridors in the Commonwealth. The study team has updated the project information website to provide details about potential solutions to the problems identified during the first round of public input.

Comments will be received via a survey, found at wa64corridor2.metroquest.com, that asks users a series of questions about their commuting habits and solicits information about their preferences among a host of potential solutions.
