The RRTPO Vision Zero Work Group meeting was held by electronic communication means as set forth by the April 22, 2020 actions of the General Assembly in response to the continued spread of novel coronavirus, or COVID-19. **CALL TO ORDER**

Dironna Moore Clarke, Richmond Regional Transportation Planning Organization (RRTPO) Vision Zero Work Group Chair, presided and called the October 8, 2020 RRTPO Vision Zero Work Group meeting to order at 3:05 p.m.

**ATTENDANCE ROLL CALL & CERTIFICATION OF MEETING QUORUM**

Nicole Mueller, Program Coordinator, took attendance by roll call and certified that a quorum was present.

**1. Approval of the October 8, 2020 Vision Zero Work Group Meeting Agenda**

On motion of Sharon Smidler, seconded by Tom Coleman, the Vision Zero Work Group unanimously approved the October 8, 2020 meeting agenda as presented.

**2. Approval of the August 13, 2020 Vision Zero Work Group Meeting Summary**

On motion of Sharon Smidler, seconded by Tom Coleman, the Vision Zero Work Group unanimously approved the summary of the August 13, 2020 meeting as presented.

**3. Vision Zero Work Group Chairman's Report**

Chairwoman Clarke shared a document with the work group for email distribution called [Moving from Vision to Action: Fundamental Principles, Policies & Practices to Advance Vision Zero in the U.S.](#) to be used as a tool to begin the conversation with the localities of how to move the Vision Zero work forward.

**4. Deliverables to RRTPO Technical Advisory Committee (TAC)**

The work group discussed the development of a Vision Zero framework for the region. The following main components of a draft outline for a regional action plan were workshopped:

### Vision Zero Education and Fundamental Principles

- Introduction
  - How do safety programs like Vision Zero and [Toward Zero Deaths](#) work?
  - What types of regional solutions / best practices exist?

### The Need for Vision Zero: Defining the Problem

- Regional Crash Experience ([VDOT Crash Data Analysis Tools](#))
- Key Findings / Issues

### Roadmap to Regional Action

- Proposed Strategies and Actions
  - Regional Transportation Forum
  - First Year Priorities
  - Stakeholder Pledge
  - Safety and Healthy Streets Challenge

Mike Sawyer, City of Richmond Transportation Engineer, recommended using VDOT's on-call consultant to revise the scope of work to complete the direction given by the work group. Staff will work on a draft deliverable outline for a regional action plan for RRTPO TAC consideration.

## **5. Local Transportation Committee Updates**

### City of Richmond Update

- The Vision Zero Task force made recommendations on General Assembly safety legislation during their last quarterly meeting;
- Engineering countermeasures are being deployed throughout the City of Richmond;
- The Richmond Police Department provided information on their enforcement efforts;
- The Department of Public works along with the Richmond Police Department, Richmond City Health Department and Richmond Behavioral Health discussed a new high-risk impaired driving action plan. 9 out of 12 fatalities are unbelted, 592 deaths and serious injuries so far in 2020; of those, one out of three are unbelted for the region;
- The Safe & Healthy Streets Commission meeting will be held later in the month of October.

### Chesterfield County Update

- Staff met with the police department to address lighting concerns along Jefferson Davis Highway, Hull St and other high crash corridors. Process of applying for an AARP Community Challenge grant to address some of those lighting concerns in in some the high crash corridors.
- The Internal Risk Management Department and the social media team share safety tips and leadership talking points throughout the county.

### Henrico County Update

- Staff also share the City of Richmond's safety updates and leadership talking points;
- Quarterly meeting was held with the Traffic Engineering Division, the Transportation Development Division, Henrico Police, VDOT Traffic Engineering, and Ashland residency to talk about serious crashes in Henrico and identify the top 10 crash locations in the county.

**6. VDOT Assisted Regional Forum**

Before a regional forum takes place, it is important to define the problem and understand the most critical components of Vision Zero. Roundtable discussions with elected officials, who explore and deliberate on regional crash experiences and the key findings and issues, may be a tool to build collaboration and assist with the decision-making process. The annual regional transportation forum could provide a roundtable discussion format.

There were no requests to address the Vision Zero Work Group.

**8. Vision Zero Work Group Member Comments**

No comments were offered.
